The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Member for St. George's – Stephenville East (Mr. Reid) made a Statement to recognize Director Michael Fenwick and a team of film students who are working on a film about Emile Benoit.

The Honourable the Speaker (Mr. Verge), in compliance with Sections 8 and 10 of the *Public Tender Act*, tabled the Report of *Public Tender Act* Exceptions for March, 2015.

The Member for Port au Port (Mr. Cornect) gave notice that he would on tomorrow ask leave to introduce the following Resolution:

"BE IT RESOLVED that this Honourable House condemns and seeks the immediate reversal of the Federal Department of Fisheries and Oceans' decision to divide the 172.8–tonne increase in the halibut quota equally among eight groups instead of respecting this Province's traditional share of 29.1% - a decision that will reduce the additional share available to Newfoundland and Labrador from 50 tons to about 21 tons".

The Honourable the Government House Leader (Mr. King) announced pursuant to Standing Order 63(3) that the Resolution of which the Member for Port au Port (Mr. Cornect) had given notice would be debated on Private Members' Day, Wednesday, May 27th.

The Member for Carbonear – Harbour Grace (Mr. Slade) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to increase moose/vehicle accident mitigation measures, including moose fencing, brush cutting and increasing quotas, and to provide financial assistance to those most seriously injured as a result of said collisions.

The Member for Trinity – Bay de Verde (Mr. Crocker) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to ensure the cleanup of the site of a commercial building destroyed by fire occurs.

The Member for Cartwright – L'Anse au Clair (Ms. Dempster) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to allocate resources to allow for permanent resurfacing of Route 510 from L'Anse au Clair to Red Bay.

The Member for Conception Bay South (Mr. Hillier) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to allocate funding to include brush clearing to reduce the risk of moosevehicle accidents on the Manuels Access Road.

The Member for The Straits – White Bay North (Mr. Mitchelmore) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to carry out a study that will include a geological assessment and a full cost analysis of the feasibility of constructing a fixed link across the Strait of Bell Isle.

Pursuant to order and on motion debate continued on the amendment to the Budget motion (being a non-confidence motion) and on motion debate adjourned for further debate on tomorrow.
