The Honourable the Premier (Mr. Ball) made a Statement to congratulate the community of Cartwright, overall winners of the Labrador Winter Games, and all those who participated in the event.

The Honourable the Minister of Service NL (Mr. Joyce) made a Statement to inform the House about Service NL's online driver licence renewal service.

The Honourable the Minister of Environment and Conservation (Mr. Trimper) made a Statement to recognize United Nations World Water Day.

The Honourable the Minister of Natural Resources (Ms. Coady), in accordance with the *Energy Corporation Act* and the *Hydro Corporation Act*, tabled the following:

- (a) the 2015 Business and Financial Report for Nalcor Energy;
- (b) the 2015 Consolidated Financial Statements of Newfoundland and Labrador Hydro.

The Honourable the Minister of Natural Resources (Ms. Coady) also tabled a document entitled Meeting the Expectations of Canadians Review of the Governance Framework for Canada's Crown Corporations.

The Member for Cape St. Francis (Mr. Parsons) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to be vigilant and vocal in demanding that the Federal Government live up to its commitment to provide \$280 million for the fisheries innovation fund.

On motion of the Honourable the Government House Leader (Mr. Parsons) the House resolved itself into a Committee of the Whole House to consider a certain Resolution and Bill No. 9 "An Act To Amend The Loan Act, 2015".

The Speaker left the Chair.

Mr. Lane took the Chair of Committee of the Whole House.

On motion the Committee rose.

The Speaker resumed the Chair.

The Chairperson of the Committee of the Whole (Ms. Dempster) reported that the Committee of the Whole House had considered the matters to them referred and had directed her to report that they had adopted a certain Resolution and the Bill consequent thereto and recommended that Bill No. 9 be introduced to give effect to the Resolution.

On motion the report of the Committee of the Whole was received and adopted.

Pursuant to order and on motion the following Resolution was read the first and second time:

"That it is expedient to bring in a measure to authorize the raising from time to time by way of loan on the credit of the province, in addition to the sum of money already voted, a sum of money not exceeding \$400,000,000."

Pursuant to order and on motion the Bill entitled "An Act To Amend The Loan Act, 2015" (Bill No. 9) was read the first, second and third time and passed.

On motion it was ordered that Bill No. 9 be printed being entitled as above and that it be submitted to His Honour the Lieutenant Governor for his assent.

Pursuant to order and on motion debate continued on the Address in Reply and on motion debate was adjourned for further debate on tomorrow.
