Pursuant to order and on motion debate commenced and concluded on the following Resolution standing in the name of the Member for Fortune Bay – Cape La Hune (Ms. Perry):

"WHEREAS the remains of a Beothuk woman named Demasduit, and her husband, a chief named Nonosbawsut, have for many years been in storage in Edinburgh at the National Museum of Scotland;

AND WHEREAS the remains of these Aboriginal people of Newfoundland and Labrador should be repatriated to Newfoundland and Labrador, Canada, and laid to rest in the place where the Beothuk people lived;

THEREFORE BE IT RESOLVED that this Honourable House call on the Government of the United Kingdom to facilitate the repatriation of the remains of Demasduit and Nonosbawsut to Canada so that they may be laid to rest with dignity."

The Speaker put the question on the Resolution and declared the Resolution carried.

The Speaker then adjourned the House until Thursday at 1:30 p.m., pursuant to Standing Order 9.
