The Honourable the Minister of Environment and Conservation (Mr. Trimper) made a Statement to recognize June 5 – 11 as Canadian Environment Week.

The Honourable the Minister of Health and Community Services (Mr. Haggie) made a Statement to recognize June 5th as National Cancer Survivors Day.

The Honourable the Minister of Seniors, Wellness and Social Development (Ms. Gambin-Walsh) made a Statement to recognize June as Seniors Month in Newfoundland and Labrador.

The Member for Stephenville – Port au Port (Mr. Finn) gave notice that he would on tomorrow ask leave to introduce the following Resolution:

"WHEREAS Terry Fox began his Marathon of Hope on April 12, 1980 in St. John's, Newfoundland and Labrador with a dream of creating awareness of cancer and raising \$1,000,000 to find a cure;

AND WHEREAS Terry Fox, at the age of 21 and having had a leg amputated due to bone cancer, endeavored to run across Canada, covering 5,373 kilometers over 143 days, the equivalent to a 42-kilometre marathon each day until he was forced to stop due to a recurrence of cancer;

AND WHEREAS after the first 25 days, and with growing encouragement from residents along the way, Terry Fox stopped in Channel-Port aux Basques where that town alone raised \$10,000;

AND WHEREAS the generous response from people in Port aux Basques fired his imagination and a new fundraising goal of one dollar for every Canadian was set;

AND WHEREAS in the past 36 years, more than \$650 million has been raised in Terry Fox's name to support cancer research;

AND WHEREAS Terry Fox and his family continue to be an inspiration to school children and communities throughout Newfoundland and Labrador, Canada, and around the world:

AND WHEREAS Terry Fox's courageous journey began in Newfoundland and Labrador and gave his dream a momentum that endures;

BE IT THEREFORE RESOLVED that this Honourable House supports the decision to proclaim the second Sunday after Labour Day in each year throughout Newfoundland and Labrador as Terry Fox Day."

The Member for St. John's Centre (Ms. Rogers) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to ensure that the Deficit Reduction Levy is eliminated and any replacement measure is based on progressive taxation principles and that an independent review of the provincial tax system begins immediately.

The Member for Conception Bay South (Mr. Petten) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to reverse the decision to make cuts to teachers and to our educational system, which will have a negative effect on the students.

The Member for Cape St. Francis (Mr. Parsons) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to reverse the decision to close the Pouch Cove Library.

The Speaker put the question on the motion and declared the motion carried.

Pursuant to order and on motion the Bill entitled "An Act To Amend The Victims Of Crime Services Act" (Bill No. 36) was read the second time and on motion it was ordered that Bill No. 36 be referred to a Committee of the Whole now.

On motion of the Honourable the Government House Leader (Mr. Parsons) the House resolved itself into a Committee of the Whole House to consider a Bill entitled "An Act To Amend The Victims Of Crime Services Act" (Bill No. 36).

The Speaker left the Chair.

Ms. Dempster took the Chair of Committee of the Whole House.
