The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Member for Ferryland (Mr. Hutchings) made a Statement to honour Ken Williams for his contribution to hockey on the Southern Shore and in Newfoundland and Labrador.

The Member for Mount Pearl North (Mr. Kent) made a Statement to congratulate Reginald White who has been named a Senior of Distinction.

The Member for Torngat Mountains (Mr. Edmunds) made a Statement to congratulate and thank Mr. Ronald James Anderson who has been awarded the Medal of Bravery for saving the lives of two snowmobilers who went through the ice near Nain Bay in 2015.

The Member for St. John's Centre (Ms. Rogers) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to keep libraries open and work on a long term plan to strengthen the library system.

The Member for Mount Pearl – Southlands (Mr. Lane) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to strike an all-party committee on school busing to make recommendations to Government for the improvement of the school busing system in the province.
