The Member for St. John's Centre (Ms. Rogers) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to keep libraries open and work on a long term plan to strengthen the library system.

The Member for St. John's East – Quidi Vidi (Ms. Michael) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to legislate an immediate increase in the minimum wage and an annual adjustment to the minimum wage, beginning in 2016, to reflect the Consumer Price Index.

The Member for Cape St. Francis (Mr. Parsons) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to take immediate action to develop markets for groundfish in the Province and with our trading partners.

The Member for Conception Bay East – Bell Island (Mr. Brazil) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to reverse the decision to cut teacher allocations and funding for education.
