The Member for Fortune Bay – Cape La Hune (Ms. Perry) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to reverse fee increases introduced through Budget 2016 immediately.

Pursuant to order and on motion debate commenced on the following Resolution standing in the name of the Member for Topsail - Paradise (Mr. Paul Davis):

"BE IT RESOLVED that any and all agreements respecting Churchill River hydro power shall be brought to the House of Assembly for public debate and Members' vote prior to ratification."

During the debate, the Honourable the Minister of Natural Resources (Ms. Coady), seconded by the Member for Labrador West (Mr. Letto) moved the following amendment:

"That the Resolution be amended by deleting the words "any and all Agreements respecting Churchill River Hydro power" and by substituting the words "all future agreements respecting Churchill River Hydro Power developments and renegotiation of the Upper Churchill Power contract".

The Speaker (Mr. Warr) suspended the proceedings at 3:26 o'clock in the afternoon to consider the amendment.

The Speaker (Mr. Warr) resumed the Chair at 3:29 o'clock in the afternoon and ruled the amendment in order.

Debate continued and concluded on the amendment to the Resolution and the Resolution itself.

The Speaker put the question on the amendment and declared the amendment carried.
