The Member for Ferryland (Mr. Hutchings) made a Statement to congratulate the Mobile Monarchs High School Hockey Team and coaches on the Team's accomplishment in winning the Tier 2 Confederation Cup.

The Member for Conception Bay South (Mr. Petten) made a Statement to congratulate the Studio 5ive art group on the success of their recent Art Exhibition and Sale and commend them for their contribution to the community.

The Member for Mount Pearl North (Mr. Kent) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to increase mental health services and programmes in the Province's K-12 school system.

The Member for Conception Bay East – Bell Island (Mr. Brazil) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to introduce a suite of initiatives to enhance inclusion in education.

The Member for St. John's Centre (Ms. Rogers) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government not to impose a provincial sales tax on books.
