NOW THEREFORE BE IT RESOLVED that this House requests that the Speaker, as a servant of this Honourable House and therefore a representative of the people of the Province of Newfoundland and Labrador, journey to Turkey to advance discussions towards a shared goal of establishing a memorial commemorating the significant contributions of the Royal Newfoundland Regiment at Gallipoli".
