

Monday, March 5<sup>th</sup>, 2018

The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Member for Lewisporte – Twillingate (Mr. Bennett) made a Statement to thank Lewisporte Fire Rescue for their service to the community and commend Fire Fighter of the Year, Dave Ryan, for his dedicated service.

The Member for Fogo Island – Cape Freels (Mr. Bragg) made a Statement to congratulate the festival committee and volunteers for having organized this year's successful Centerville-Wareham-Trinity and Indian Bay winter festival.

The Member for Conception Bay East – Bell Island (Mr. Brazil) made a Statement to congratulate Joyce Churchill on her appointment to the Order of Canada.

The Member for Placentia West – Bellevue (Mr. Browne) made a Statement to recognize Loretta Ryan and Kelsie Lockyer for their volunteer work in Nicaragua with Operation Broken Earth.

The Member for Virginia Waters – Pleasantville (Mr. Davis) made a Statement to pay tribute to the Chinese Association of Newfoundland and Labrador on the occasion of the 2018 New Year Celebration.

The Honourable the Minister of Children, Seniors and Social Development (Ms. Dempster) made a Statement to pay tribute to social workers during National Social Work Month.

The Honourable the Minister of Tourism, Culture, Industry and Innovation (Mr. Mitchelmore) made a Statement to laud the achievements of the Newfoundland and Labrador film and television industry.

The Member for Torngat Mountains (Mr. Edmunds) gave notice that he would on tomorrow ask leave to introduce the following Resolution:

**“WHEREAS** gender-based violence remains a reality for many women and girls in Newfoundland and Labrador;

**AND WHEREAS** Indigenous women across the country experience a rate of violence three times higher than non-Indigenous women and are murdered at a rate six times higher;

**AND WHEREAS** the Moose Hide Campaign is a grassroots movement of Indigenous and non-Indigenous men taking a stand against violence against women and children across Canada;

**AND WHEREAS** the Moose Hide Campaign promotes the wearing of a small piece of moose hide signifying the wearer's commitment to honour, respect and protect the women and children in their lives, and to work collaboratively with other men to end gender-based violence;

**AND WHEREAS** the Moose Hide Campaign movement has spread to over 350 communities across Canada and distributed over one million moose hide pins;

**THEREFORE BE IT RESOLVED** that this Honourable House encourages all Members of the House of Assembly to support the Moose Hide Campaign and work towards ending violence against all women and children in Newfoundland and Labrador.”
