The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Member for Ferryland (Mr. Hutchings) made a Statement to congratulate the volunteers of the town of Petty Harbour Maddox Cove and thank them for their valuable service to the community.

The Member for Conception Bay South (Mr. Petten) made a Statement to congratulate the 2562 Queen Elizabeth Army Cadet Corps on the occasion of their Annual Ceremonial Review and extend best wishes to them for their continued success.

The Member for St. George's - Humber (Mr. Reid) made a Statement to acknowledge The Flat Bay Pow Wow which will be held from July 13<sup>th</sup> - 15<sup>th</sup>.

The Member for Baie Verte – Green Bay (Mr. Warr) made a Statement to recognize the entrepreneurial achievements of Mr. Wilbert Weir and congratulate him on his election as Deputy Mayor of Little Bay Islands, just four days short of his  $90^{th}$  birthday.

The Leader of the Official Opposition (Mr. Brazil) extended best wishes to Members and staff for the summer break.

The Speaker suspended the proceedings to await the arrival of Her Honour the Lieutenant Governor.

At 5:06 o'clock in the afternoon, the Sergeant-at-Arms announced the arrival of Her Honour the Lieutenant Governor.

The Speaker left the Chair.

Her Honour the Lieutenant Governor took the Chair.

The Speaker addressed Her Honour the Lieutenant Governor as follows:

"It is my agreeable duty on behalf of Her Majesty's dutiful and loyal subjects, Her Faithful Commons in Newfoundland and Labrador, to present to Your Honour a Bill for the appropriation of Supply granted in the present Session".
