Pursuant to order and on motion the Bill entitled "An Act To Amend The Housing Corporation Act" (Bill No 40) was read the second time and on motion it was ordered that Bill No. 40 be referred to a Committee of the Whole now.

On motion it was ordered that the said Bill be printed being entitled as above and that it be submitted to Her Honour the Lieutenant Governor for her assent.

It was moved and seconded that when the House rose it would adjourn until tomorrow, Monday, December 3rd at 1:30 o'clock in the afternoon.
