By-Election: Humber West February 15, 2011

On Monday, January 24, 2011, the Writ of Election was issued for a by-election in the electoral district of Humber West. The election date was set for February 15, 2011 and was called to fill a vacancy which resulted from Danny Williams' resignation as Premier and Member of the House of Assembly on December 3, 2010.

The list of electors printed on January 6 was used as the preliminary list, containing 8410 electors. Updates to the list were made during the election period until 8 p.m. on February 10 (advance poll day), when a final revised list containing 8898 electors was subsequently printed. The final revised list identified electors who applied to vote by Special Ballot, who voted at the advance poll and who applied to be added to the list (as well as other changes such as elector moves or corrections to electors' names and/or addresses). On Friday, February 11 the final revised list was given to the district Returning Officer for distribution to the political parties and candidates. The same list was used by the Returning Officer and all election officials as the official list of electors on polling day.

Nomination day was held on Saturday, February 5 and three candidates were officially nominated: Vaughn Granter for the Progressive Conservative Party, Rosie Myers for the New Democratic Party and Mark Watton for the Liberal Party.

The advance poll was held on Thursday, February 10 in Corner Brook.

A total of 102 Special Ballot applications were received and approved and 101 ballot kits were returned by the deadline of 4:00 p.m. on Friday, February 11. This means that 99 per cent of ballots were returned to the Office of the Chief Electoral Officer (OCEO).

The preliminary count on election night resulted in 3321 votes cast. A total of 213 votes were cast at one advance poll; 101 votes were cast by Special Ballot; and 3007 votes were cast at 33 regular polls, resulting in a 37 per cent voter turnout. Vaughn Granter received 2109 votes, Rosie Myers received 112 votes and Mark Watton received 1097 votes. There were three rejected ballots, two cancelled ballots and 205 electors were "sworn in" at the advance poll, by Special Ballot and on polling day.

The official addition of the votes was held on Friday, February 18 at the district Returning Office. The official addition confirmed the preliminary count reported on election night and there was no change reported in the counts for any of the candidates. Mr. Vaughn Granter was declared elected and was sworn in as a member of the House of Assembly on Wednesday, March 16, 2011. The results of this by-election left representation in the House of Assembly with 43 Progressive Conservatives, four Liberals and one New Democrat.

The Chief Electoral Officer would like to extend appreciation to the district staff for overseeing an efficient by-election: Sylvia Wheeler (Returning Officer), Sheila Crocker (Election Clerk) and John Edgar (Special Ballot Officer). Thanks are also extended to the rest of the district election workers and the staff at the Office of the Chief Electoral Officer for an excellent job.
