Members assist and support the Senior Project Team<sup>1</sup> by providing comment on biological, social, economic and operational considerations, and through forwarding inquiries, views and concerns from stakeholder groups through their committee representative. This may include advice on proposed activities, and/or comment on the progress and success of the Strategy's ongoing efforts. The committee also serves to assist and support in the dissemination of relevant information from the Senior Project Team to stakeholder groups.

The Terms of Reference for the committee has established a meeting frequency of twice annually. The secretariat for the committee operates out of the Sustainable Development and Strategic Science (SDSS) offices in St. John's, and functions as an administrative body, and a conduit for two-way exchange between committee members and the Senior Project Team responsible for the Caribou Strategy.

Committee members serve on a volunteer basis, with travel, accommodations and related costs covered under the Caribou Strategy budget within the Sustainable Development and Strategic Science Branch.

### Vision

The vision of the Caribou Resource Committee is a healthy and sustainable population of woodland caribou on the island of Newfoundland that meets the social, cultural, ecological and economic needs of its residents at present, and in the future.

## Mission

The mission of the Caribou Resource Committee reflects the intent of the Department, which is the reduction of adverse impacts of human activities on the environment and the improvement of the health of our ecosystems. By supporting the deliberations of the Caribou Strategy, the committee will enhance the Senior Project Team's ability to effectively and sustainably manage an integral species in our ecosystem, which in turn will promote a more robust environment.

## Activities

The Caribou Resource Committee met once during the 2012-2013 fiscal year. The committee was unable to find a second date where schedules allowed a majority of members (or alternates) to attend. The meeting took place 18-19 December 2012 in St. John's.

The agenda for this meeting included an update of the Caribou Strategy activities and progress, the habitat mapping project, caribou diet and nutrition, spatial behaviour of caribou and predators, results to date for the predator reduction experiments, and results of a calving ground survey in the Middle Ridge herd range. A Memorial University graduate student joined the committee as a guest on the second day to present her work on caribou anti-predator behaviour. The committee spent some time discussing the review of caribou populations across Canada currently being conducted by the Committee on the Status of Endangered Wildlife in Canada (COSEWIC) under authority of the federal Species At Risk Act.

Despite only having one meeting, committee members were in regular contact with SDSS to seek information or provide comment on the Caribou Strategy on behalf of their represented group.

# Objective and Accomplishments

The Caribou Resource Committee has supported the Caribou Strategy by providing meaningful input and comment to the Senior Project Team. Additionally, members continue to report to their respective stakeholder groups on deliberations and outcomes of

committee meetings and informal communication, which serves to propagate information to a broader audience.

Specifically, members have provided input and participated in discussions regarding the predator reduction experiments, Caribou Strategy progress, and opinion on management, research and communication directions and efforts for the future.

The CRC will advise on ways to increase public awareness and efficiently disseminate information on the activities and progress of the Caribou Strategy to a wider group of stakeholders.	Various presentations were made to the CRC members during the December meeting. Topics included progress and status of the Caribou Strategy and aspects of caribou and predator biology and ecology. These presentations provide information for representatives to disseminate to their stakeholdergroup. Discussions at the meeting included topics of current events relevant to caribou generally and Newfoundland caribou in particular (such as the COSEWIC review in progress).  Members reported information was shared with their represented groups throughout year. Consistent with the variation in stakeholder groups, information was shared in multiple ways, such as:  • Discussion of member's thoughts and impressions of CRC meetings via email, presentation at stakeholder group gatherings/meetings, personal interaction with individuals expressing interest;  • Electronic distribution of materials provided to the CRC members for the purpose of distribution to all or part of stakeholder group;  • Seeking clarification from SDSS of shared information on behalf of individuals within stakeholder groups.

The Senior Project Team continued to take these views and opinions into consideration when developing caribou management recommendations.
