## Message from the Minister

The 2012-13 Annual Report on Newfoundland and Labrador's Access to Information and Protection of Privacy Act (the "Act") is provided in accordance with section 70 of the legislation.

In 2012-13, public bodies across Newfoundland and Labrador received 660 requests for general access and personal information - a 23 percent increase from the 537 requests received in 2011-12.

The sustained efforts of the public bodies that process access to information requests, together with the support of the Access to Information and Protection of Privacy (ATIPP) Office, have led to the results that are contained in this report.

During the 2012-13 fiscal year, the ATIPP Office commenced several new initiatives in line with the Government of Newfoundland and Labrador's commitment to openness and accountability to the people of this province. These initiatives are ongoing and the provincial government is committed to implementing new ways for people to access government information and to protect the personal and confidential information in its possession.

Some of the achievements of the 2012-13 fiscal year include:

- The ATIPP Office consulted with government departments with respect to increased proactive disclosure and making more government information publicly available and easily accessible through online posting. For example, the ATIPP Office commenced work relating to the online posting of Orders in Council and government department general access requests for launch in 2013-14.
- In partnership with the Office of the Chief Information Officer, the ATIPP Office began the development of a webpage which would provide a central location for the public to access government information. This information can be found at: <u>http://www.ope.gov.nl.ca/openinfo/proactive\_disclosures.html</u>.
- The Office has updated the Access to Information and Protection of Privacy Policy and Procedure Manuals. Additionally, forms and other resources were updated to reflect the amendments made to the ATIPP Act in 2012. These materials can be found at: <u>http://</u><u>www.atipp.gov.nl.ca</u>.
- 4. Training was provided across Newfoundland and Labrador in relation to amendments made to the in 2012.

## **Overview**

The Access to Information and Protection of Privacy Act (the "Act") was proclaimed in January 2005 and was amended in June 2012, following the first statutory review. Its provisions apply to more than 460 public bodies across the province, including government departments, agencies, boards, commissions, crown corporations, health authorities, educational bodies and municipalities. The purpose of this Act is to make public bodies more accountable to the public by providing access to information and protecting personal privacy.

With respect to access to information, two categories of information are accessible to the public under the Act: general information and personal information. The Act specifies a framework for providing information to applicants. A request for general information relates to information about government. Some examples include reports, expenses and statistics. Personal information requests are requests made by individuals seeking access to their own personal information that is in the custody of government or other public bodies.

The Act also provides a mechanism for resolving disputes with respect to the processing of access to information requests. If an applicant is not satisfied with the handling of an access to information request by a public body, a complaint or request for review can be made to the Office of the Information and Privacy Commissioner (OIPC) or Trial Division of the Supreme Court of Newfoundland and Labrador. The OIPC can review records that are the subject of a complaint with the narrow exception of official cabinet records and solicitor and client privilege records.

The Access to Information and Protection of Privacy (ATIPP) Office is responsible for the overall administration and coordination of the legislation. The Office monitors the administration of the Act by collecting and maintaining statistics on access to information requests supplied by departments and public bodies as defined by the Act. In compliance with section 70 of the Act, this report includes: the number of requests for access and whether they were granted or denied; the specific provisions of the Act used to refuse access; the number of applications to correct personal information; and the fees charged for access to records.

The ATIPP Office also provides support and leadership in the interpretation and application of the Act by assisting public bodies with education and training, developing policies and procedures to foster common standards, and providing advice and guidance on the processes necessary to ensure the Act is implemented and applied appropriately. Each public body is required to designate an access and privacy coordinator responsible for receiving and processing access requests as well as coordinating responses for the relevant public body.

## **Statistical Reports**

The next section of this report provides a statistical breakdown of the total number of general and personal access requests received from April 1, 2012 to March 31, 2013 for government departments and public bodies. Public bodies include government agencies, boards, commissions, municipalities, crown corporations, health care and educational bodies.

Departments and public bodies that did not receive any requests for access are not included in the breakdown of statistics. Please refer to Annex A for a listing of these entities.

### **General Access Requests**

Requests for general information cover a wide range of subjects and records, from policy documents to travel claims or archived records. This section reports the volume and applicant type for general access requests made to government departments and public bodies. The data is detailed further to report fees recorded, exceptions to disclosure applied and outcomes of requests.

### Volume and Applicant Type

During the 2012-13 fiscal year a total of 511 general access requests were received by government departments and public bodies. Of these 511 requests, government departments received 285 (56%) general access requests and other public bodies received 226 (44%) general access requests.

#### Fees

Section 68 of the Act gives the Minister responsible for the Act the right to establish a Fee Schedule. The current fee schedule came into effect December 10, 2012 and outlines the applicable fees for access to information requests (see Annex B). Specifically, fees for general access requests include: \$5.00 application fee; \$25.00/hour<sup>1</sup> for locating, retrieving, providing, manually producing, and severing records; \$0.25/page for photocopies; and any associated shipping costs. Fees are not charged for the first four hours<sup>2</sup> of work to respond to an access request. The head of a public body may waive the requirement to pay any fees if payment would impose an unreasonable financial hardship on the applicant. The \$5.00 application fee may be charged for personal information requests, however, the head of the department or public body may waive the application fee for personal information requests if deemed reasonable and fair in the circumstances. No processing fees can be charged for personal information requests.

#### **Application Fees**

During 2012-13, application fees received by government departments and public bodies totaled \$2,860.00.

#### Exceptions

One of the main purposes of the Act is to provide access to information subject only to specific and limited circumstances. Under the Act, certain types of information are exempt from disclosure to applicants. There are two categories of exceptions: mandatory exceptions, which departments and public bodies must apply; and discretionary exceptions, which departments and public bodies may exercise discretion to apply.

Since a single request may list more than one exception, the numbers noted in this table do not correlate to the total number of general access requests received during this timeframe. For example, one record or piece of information could be severed citing cabinet confidences (s.18), policy advice or recommendations (s.20) and harmful to the financial or economic interests of a public body (s.24).

#### Synopsis

The exceptions to disclosure listed above were used in 301 instances. Section 30 (mandatory exception for personal information) was the most widely applied exception being used in 139 (46%) instances of all applied exceptions. Discretionary exceptions were used in 103 (34%) instances of all applied exceptions.

#### Outcomes

Responding to general access requests can result in a range of possible outcomes. The outcome may be full or partial disclosure; the applicant may withdraw or abandon the request; or the record may not exist or may already be available in the public domain. Partial disclosure means exceptions have been applied and certain information has been severed in accordance with the legislation.

#### Synopsis

Of the 284 general access requests responded to by government departments, 197 (69.3%) resulted in full or partial disclosure, while 45 (15.9%) general requests were for records that did not exist. Access was denied to only 25 (8.8%) of the general requests received. As noted, the total general access responses in Table 7 do not equal the total general access requests made to departments for the 2012-2013 fiscal year. This discrepancy is due to one outstanding request that was still under review by the OIPC.

### Synopsis

Of the 223 general access requests responded to by public bodies, 162 (72.7%) resulted in full or partial disclosure. Access was denied in 16 (7.2%) of the general requests received and records did not exist for 12 (5.4%) of the general requests received. As noted, the total general access responses in Table 8 do not equal the total general access requests made to public bodies for the 2012-13 fiscal year. This discrepancy is due to three outstanding requests that were still under review by the OIPC.

## Personal Information Requests

Personal information can be requested by the individual the information is about or by another individual who has been delegated authority on behalf of that person. Requests for personal information are subject to an application fee of \$5.00. No additional fees may be charged.

#### Synopsis

The same exceptions which apply to general access requests may also apply to requests for personal information. The exceptions to disclosure listed above were used in 116 instances. Section 30 (mandatory exception for personal information), was the most widely applied exception. This section was used in 77 (66.5%) instances of all exceptions. Discretionary exceptions were used in 37 (31.5%) instances of all applied exceptions.

The outcomes of personal information requests are depicted in Table 11 for government departments and Table 12 for other public bodies.

## Synopsis

Of the 32 personal information requests responded to by government departments, 19 (59%) requests resulted in full or partial disclosure. Six (19%) of these applications requested records that did not exist and access was denied in two (6%) of the personal information requests. The two cases where access was denied were the result of a request for an individual's personal information other than the applicant and no consent was received to disclose the information (denied under s.30) and a request for records relating to a labour dispute (denied under s.26.1 which states that information cannot be disclosed where it would be harmful to the labour relations interests of a public body as an employer).

#### Synopsis

Of the 116 personal information requests responded to by public bodies, 100 (86%) requests resulted in full or partial disclosure. Eight (7%) applications requested records that did not exist and access was denied in four (3%) requests.

The four cases where access was denied were for the following reasons: (1) request for an individual's personal information other than the applicant and no consent was received to disclose the information (denied under s.30); (2) records protected as legal advice (denied under s.21); (3) records from an ongoing investigation (denied under s.5); and (4) a request for records in different or electronic format that could not be reasonably produced (denied under s.10).

## **Correction of Personal Information**

Under section 35 of the Act, an individual who believes there is an error or omission in his or her personal information on record with a department or other public body may request that the relevant public body correct the information.

The Eastern School District (now part of the NL English School District) and the Town of Port au Port East each received one request for correction of personal information. No other requests for correction of personal information were reported by government departments or other public bodies for the period of April 1, 2012–March 31, 2013.

#### Establishment of Fees and Forms for the Access to Information and Protection of Privacy Act

Pursuant to Section 21 of the Executive Council Act, Section 68 of the Access to Information and Protection of Privacy Act and all other powers enabling him in this regard, the Minister of the Office of Public Engagement has been pleased to establish the fees and forms set out below, effective from the 100 day of 122002012.

#### FEES

1. (1) An applicant who makes a request for access to a record pursuant to the Access to Information and Protection of Privacy Act must pay to the public body:

- (a) an application fee in the amount of \$5.00;
- (b) \$25.00 for each hour of person time after the first four (4) hours, rounded down to the nearest hour, for the following: locating; retrieving; providing; manually producing; and severing, which includes the review of records to determine whether or not any of the exceptions to disclosure apply, and the subsequent redaction of the records if necessary;
- for producing a record from information in electronic form, the actual cost of producing the record;
- (d) for shipping a record, the actual costs of shipping using the method chosen by the applicant;
- (e) where the record is stored or recorded in printed form and can be copied or printed using conventional equipment, 25 cents a page for providing a copy or print of the record; and
- (f) where the record is stored or recorded in a manner other than that referred to in paragraph (e) or cannot be reproduced or printed on conventional equipment, the actual cost of reproduction for providing a copy of the record.
- (2) A person who requests access to his or her own personal information must pay only the application fee set out in paragraph (1)(a).
- The application fee in paragraph 1(1)(a) shall be paid at the same time the application is submitted before access to a record is given.

- 3. (1) Where fees are estimated to be \$50 or more, the public body is required to give the applicant a fee estimate. If the applicant wishes to proceed, the public body will require the applicant to pay 50 percent of the fee estimate prior to commencing the work required to respond to the request. Upon receipt of the first 50 percent of the fee estimate, the public body shall complete 50 percent of the work. The remaining 50 percent of the fee estimate must be paid prior to the public body completing the remaining 50 percent of the work.
  - (2) Where fees are estimated to be less than \$50, the public body is required to give the applicant a fee estimate. If the applicant wishes to proceed, the fee must be paid in full prior to releasing the records to the applicant.
  - (3) A head shall refund any amount paid under subsection (1) that is subsequently walved.
- Any fee estimate provided to an applicant in accordance with the previous fee schedule shall
  remain in effect until the completion of the access to information request.
- Any new fee estimate for access to information requests shall be calculated in accordance with the fee schedule, as amended, effective immediately.

#### Fees

Section 68 of the Act gives the Minister responsible for the Act the right to establish a Fee Schedule. The fee schedule in effect during the 2008-09 fiscal year outlined the applicable fees for access to information requests. Specifically, fees for general requests included: \$5.00 application fee, \$15.00/hour for locating, retrieving, providing and manually producing records, \$0.25/page for photocopies; and any associated shipping costs. The head of a public body may waive the requirement to pay any fees if payment would impose an unreasonable financial hardship on the applicant. The \$5.00 application fee may be charged for personal information requests, however, the head of the department or public body may waive the application fee for personal information requests if deemed reasonable and fair in the circumstances. No processing fees can be charged for personal information requests

#### **Application Fees**

During 2008-09, application fees received by government departments and public bodies totaled \$2,305.00.

### Annex C - 2008-09 Fiscal Year

#### Exceptions

One of the main purposes of the Act is to provide access to information subject only to specific and limited circumstances. Under the Act, certain types of information are exempt from disclosure to applicants. There are two categories of exceptions: mandatory exceptions, which departments and public bodies must apply; and discretionary exceptions, which departments and public bodies may exercise the discretion to apply.

Since a single request may list more than one exception, the numbers noted in this table do not correlate to the total number of general access requests received during this timeframe. For example, one record or piece of information could be severed citing cabinet confidences (s.18), policy advice or recommendations (s.20) and harmful to the financial and economic interests of a public body (s.24).

#### Synopsis

The exceptions to disclosure listed above were used in 318 instances. Section 30 (mandatory exception for personal information) was the most widely applied exception being used in 110 (34.6%) instances of all applied exceptions. Discretionary exceptions were used in 152 (47.8%) instances of all applied exceptions.

## Outcomes

Responding to general access requests can result in a range of possible outcomes. The outcome may be full or partial disclosure; the applicant may withdraw or abandon the request; or the record may not exist or may already be available in the public domain. Partial disclosure means exceptions have been applied and certain information has been severed in accordance with the legislation.

### Exceptions

One of the main purposes of the Act is to provide access to information subject only to specific and limited circumstances. Under the Act, certain types of information are exempt from disclosure to applicants. There are two categories of exceptions: mandatory exceptions, which departments and public bodies must apply; and discretionary exceptions, which departments and public bodies may exercise the discretion to apply.

Since a single request may list more than one exception, the numbers noted in this table do not correlate to the total number of general access requests received during this timeframe. For example, one record or piece of information could be severed citing cabinet confidences (s.18), policy advice or recommendations (s.20) and harmful to the financial and economic interests of a public body (s.24).

### Fees

Section 68 of the Act gives the Minister responsible for the Act the right to establish a Fee Schedule. The fee schedule in effect during the 2010-11 fiscal year outlined the applicable fees for access to information requests. Specifically, fees for general access requests included: \$5.00 application fee; \$15.00/hour for locating, retrieving, providing and manually producing records; \$0.25/page for photocopies; and any associated shipping costs. The head of a public body may waive the requirement to pay any fees if payment would impose an unreasonable financial hardship on the applicant. The \$5.00 application fee may be charged for personal information requests if deemed reasonable and fair in the circumstances. No processing fees can be charged for personal information requests.

#### **Application Fees**

Section 30 (mandatory exception for personal information), was the most widely applied exception being used in 144 (38.61%) instances of all applied exceptions. Discretionary exceptions were used in 151 (40.48%) instances of all applied exceptions.

# Outcomes

Responding to general access requests can result in a range of possible outcomes. The outcome may be full or partial disclosure; the applicant may withdraw or abandon the request; or the record may not exist or may already be available in the public domain. Partial disclosure means exceptions have been applied and certain information has been severed in accordance with the legislation.

## Synopsis

Of the 323 general access requests responded to by government departments, 200 (62%) resulted in full or partial disclosure, while 49 (15%) general requests were for records that did not exist and access was denied to 20 (6%) of the general requests received. As noted, the total general access responses in Table 7 do not equal the total general access requests made to government departments for the 2010-11 fiscal year. This discrepancy is as a result of one uncompleted request.

Personal Information can be requested by the individual the information is about or by another individual who has been delegated authority on behalf of that individual. Requests for personal information are subject an application fee of \$5.00. No additional fees may be charged.

# **Correction of Personal Information Requests**

#### Fees

Section 68 of the Act gives the Minister responsible for the Act the right to establish a Fee Schedule. The fee schedule in effect during the 2011- 2012 fiscal year outlined the applicable fees for access to information requests. Specifically, fees for general access requests included: \$5.00 application fee; \$15.00/hour for locating, retrieving, providing and manually producing records; \$0.25/page for photocopies; and any associated shipping costs. The head of a public body may waive the requirement to pay any fees if payment would impose an unreasonable financial hardship on the applicant. The \$5.00 application fee may be charged for personal information requests, however, the head of the department or public body may waive the application fee for personal information requests if deemed reasonable and fair in the circumstances. No processing fees can be charged for personal information requests.

#### **Application Fees**

During 2011-12, application fees received by government department and public bodies totaled \$2,405.00.

## Exceptions

One of the main purposes of the Act is to provide access to information subject only to specific and limited circumstances. Under the Act, certain types of information are exempt from disclosure to applicants. There are two categories of exceptions: mandatory exceptions, which departments and public bodies must apply; and discretionary exceptions, which departments and public bodies may exercise the discretion to apply.

Since a single request may list more than one exception, the numbers noted in this table do not correlate to the total number of general access requests received during this timeframe. For example, one record or piece of information could be severed citing cabinet confidences (s.18), policy advice or recommendations (s.20) and harmful to the financial and economic interests of a public body (s.24).

Of the 256 general access requests responded to by government departments, 193 (75.5%) resulted in full or partial disclosure, while 35 (13.5%) were for records that did not exist and access was denied in 13 (5%) of the general access requests received.

# Synopsis

Of the 192 general access requests responded to by public bodies, 141 (73%) resulted in full or partial disclosure. Access was denied to 15 (8%) of the general requests made and records did not exist for 14 (7%) of the general requests received. As noted, the total general access responses in Table 8 do not equal the total general access requests made to public bodies for the 2011-12 fiscal year. This discrepancy is due to one uncompleted request.

# Personal Information Requests

Personal Information can be requested by the individual the information is about or by another individual who has been delegated authority on behalf of that individual. Requests for personal information are subject to an application fee of \$5.00. No additional fees may be charged.

Section 2 of this Annex provides the volume and applicant type for personal information requests, exceptions and outcomes.

# Synopsis

The same exceptions which apply to general access requests also apply to requests for personal information. The exceptions to disclosure listed above were used in a total of 77 instances. Section 30 (mandatory exception for personal information) was the most widely applied exception. This section was used in 50 (65%) instances of all exceptions. Discretionary exceptions were used in 23 (30%) instances of all applied exceptions.

# Outcomes

The outcomes of personal information requests are depicted in Table 11 for government departments and Table 12 for other public bodies.

Of the 17 personal information requests responded to by government departments, 12 (70.6%) requests resulted in full or partial disclosure. Three (17.6%) of these applications requested records that did not exist and access was denied in two (11.8%) of the personal information requests.

# Synopsis

Of the 71 personal information requests responded to by public bodies, 57 (81%) requests resulted in full or partial disclosure. Six (8%) applications requested records that did not exists and access was denied in four (6%) requests.

# **Correction of Personal Information Requests**

Under section 35 of the Act, an individual who believes there is an error or omission in his or her personal information on record with a department may request that the relevant public body correct the information.

No requests for correction of personal information were reported by government departments or other public bodies for the period of April 1, 2011 - March 31, 2012.
