Tabling of Documents – Position Eliminations and Position Creations Associated with Changes to Management Structure

May 11, 2017

Mr. Speaker, as per my commitment in this House, today I am tabling a list of positions eliminated, as well as a list of positions created, as a result of changes to the management structure announced in February. This information reflects actions taken as of May 8, 2017. There are a number of items I wish to highlight, and these are noted as footnotes in the materials I am tabling.

The term "actioned," for the purpose of this report, means that the department has notified any impacted employees. In all but 16 cases, the position has been vacated and is ready to be eliminated. The 16 positions have employees attached to them and these employees have been notified that the position will be abolished at a later date. Therefore, the net reduction is 292 positions, reflecting actions taken as of May 8th.

With respect to position creations, there are some positions yet to be created but because that action has not occurred yet, these are not included in the list.
