Dear Speaker:

Section 214 of the Elections Act states that "The Chief Electoral Office shall publish within 9 months after each general election and each by election a book containing pertinent statistics of the election, including poll by poll results of each electoral district." That report with respect to the November 1, 2006 By Election in the electoral district of Signal Hill-Quidi Vidi is now complete.

Section 273(3) states that "The Chief Electoral Officer shall report annually to the Speaker upon the affairs of the Office of the Chief Electoral Officer under this part and the report shall be laid before the House of Assembly at the first convenient opportunity."

I am enclosing at this time copies of the Signal Hill-Quidi Vidi By Election for distribution to Members of the House of Assembly as per Section 19.1 (1) and (2) of the House of Assembly Act as outlined below.

19.1 (1) Notwithstanding another Act, where a report or other document that an officer of the House of Assembly is required to submit to the House of Assembly is submitted to the Speaker or the Clerk of the House of Assembly when the Assembly is not in session, the Speaker or the Clerk shall provide a copy to each member and make it available for inspection by the public immediately after the report or other document is submitted.

(2) A report or other document is considered to have been tabled before the House of Assembly when it is submitted to the Speaker or Clerk under subsection (1).

## **SIGNAL HILL - QUIDI VIDI BY ELECTION**

On Tuesday, October 10, 2006 a Writ of Election was issued for a By Election in the Electoral District of Signal Hill - Quidi Vidi to be held on Wednesday, November 1, 2006. The By Election was called to fill a vacancy created by the resignation of New Democrat, Mr Jack Harris, on Friday, September 29, 2006.

The List of Electors completed on Tuesday, October 10, 2006 and contained 8164 electors was used as the Preliminary List. Throughout the election period, updates to the list continued to be made until Saturday, October 28, 2006. A new revised List of Electors was printed on Sunday, October 29, 2006. This List identified the names of electors who applied to vote by special (mail in) ballot, the names of electors who voted at the advance poll and electors who applied to be added as well as other changes. This final revised list was distributed to political parties and candidates on Sunday, October 29 and contained a total of 1144 updates. This revised list was used by the returning officer for the electoral district and all election officials as the Official List of Electors for polling day and contained a total of 8206 electors.

Nomination Day was Sunday, October 22, 2006 with a total of two candidates officially nominated at the close; namely Jerome Kennedy for the Progressive Conservative Party, and Lorraine Michael for the New Democratic Party. Both the Liberal Party and the Newfoundland and Labrador First Party did not run a candidate in the by election.

The advance poll was held on Saturday, October 28, 2006 at one location only. A second advance poll was required to be added midday due to an increased volume of voters.

A total of 58 Special (Mail In) Ballot applications were received and approved with 56 ballot kits returned by the October 29 deadline which was a substantial decline from the February 21, 2006 by election whereby 168 special ballot kits were returned.

The preliminary count on election night resulted in 3570 votes cast. There were a total of 282 votes cast at two advance polls; 56 votes cast by special (mail in) ballot and 3232 votes cast at 30 regular polls. Mr. Kennedy received 1595 votes and Ms. Michael received 1968 votes. There were a total of 7 rejected ballots and 6 cancelled ballots. Approximately 628 electors were "sworn in" at the advance, special (mail in) ballot and at regular polls on polling day.

The Official Addition of the Votes was held on Saturday, November 4, 2006 at the Office of the Returning Officer. The results confirmed the preliminary results on election night. Ms. Lorraine Michael was declared elected after the Official Addition and was sworn in as a Member of the House of Assembly on Friday, November 17, 2006. The results of this by election left representation in the House of Assembly with 35 Progressive Conservatives, 11 Liberals and 2 New Democrats.

The Office of the Chief Electoral Officer spent approximately \$79,000 in administering the by election pursuant to the provisions of the Elections Act (exclusive of Election Finance campaign subsidies).

The Chief Electoral Officer would like to extend sincere thanks to the Returning Officer, Ms. Greer O'Brien, the Election Clerk, Ms. Grace Archibald, the election workers from the district and the staff at the Chief Electoral Office for a job well done.
