Executive Summary/Overview

The Fiscal Year April 1, 2006 - March 31, 2007 was an eventful one for the Office of the Child and Youth Advocate. The Child and Youth Advocate released the Turner Child Death Review and Investigation Findings completed by Dr. Peter Markesteyn on October 4, 2006. The Turner

Report contained a number of Recommendations with respect to child protection services, as well as Recommendations regarding the *Child and Youth Advocate Act*, the legislation which establishes the Office of the Child and Youth Advocate.

The Office was active throughout this reporting period in attending meetings with officials from the Department of Health and Community Services and also met with the Ministerial Committee established by Premier Danny Williams, Q.C. to review the Recommendations contained in the Turner Report.



The Turner Report was the first Review/Investigation Report released by the Office pursuant to the powers and duties set out in Section 15.(1) of the *Child and Youth Advocate Act*. Prior to the Turner Review and Investigation, most of the work of the Office focused on individual and, to a lesser extent, systemic advocacy, along with public education. However, the mandate of the Office has always included an oversight or investigatory function and the relevant duties are contained in Section 15.(1)(a) and (c) of the Act.

In order to achieve the broad mandate of the Office, "to protect and advance the rights and interests of children and youth", it is necessary to combine both the advocacy and investigative roles as the former serves to advance the rights and interests of children and youth while the latter serves to protect them.

This "dual" mandate requires the Office to work collaboratively with other professionals involved in the delivery of services to children and youth to ensure children and youth have access to the services they require and also requires the Office to perform an oversight role in relation to the delivery of these very services. During this reporting period the Office, in its meetings with Government and Board officials, made concentrated efforts to acknowledge this dual role while at the same time highlight the common goal of protecting and advancing the rights of children and youth shared by all.

The new staffing model established prior to the end of the previous reporting period became fully operational during this reporting period. The Office operated with eight staff, three frontline staff (Advocacy Services Specialists), one Review/Research Assistant and a Director of Advocacy Services. The Manager of Human Resources and Administration position was moved to the House of Assembly and was replaced with an Administrative Officer position. The Administrative Assistant/Receptionist position was replaced with a Clerk Stenographer/Receptionist position. Approval was sought for a Systemic Advocacy and Review/Investigation Consultant and funding was provided in Budget 2007-2008 for this position.

This Annual Report details the activities of the Office for the Fiscal Year 2006-2007 as required by Section 28 of the *Child and Youth Advocate Act* and is the fifth Annual Report for the Office of the Child and Youth Advocate.

Executive Summary Overview (contd)

Individual Advocacy

During the Fiscal Year, Advocacy staff responded to 732 new individual advocacy files. This was an increase from 467 new individual advocacy files in the previous reporting period. 527 individual advocacy files were closed during this period. Regional Visits and Advocacy Clinics were completed with a significant increase in the number of communities visited since the last Report. The ability to conduct Advocacy Clinics throughout the Province was no doubt enhanced by the new staffing model implemented during this reporting period, which included three frontline Advocacy Services Specialists.

Emerging Issues

Emerging issues files relate to issues identified through advocacy work which appear to impact groups of children and youth but require further research to determine if the systemic advocacy approach is required. At the beginning of this Fiscal Year, 19 emerging issues files were active. Throughout this reporting period, five new emerging issues, which include Child Find, Health Policy - MCP Policy for International Students and their Dependents, Homeless Youth Under the age of Sixteen, Proposed Federal Legislation Regarding Increase in Age of Consent to Sexual Activity, and Federal/Provincial Registry of Child Abusers and Sexual Offenders were identified.

Two emerging issues files were closed. The previously identified Health Services - Natuashish Emerging Issue file was combined in the larger file of Emerging Issues Affecting Innu Children in Natuashish to ensure information related to the health of children in Natuashish was considered in the broader context of all of the issues. The MCP Policy for International Students and their Dependents file was opened and closed during this reporting

period. An international student at Memorial University brought the issue that international students and their dependents were excluded from coverage under the Medical Care Plan (MCP) to the attention of the Office. This matter was successfully resolved with the Province's change in policy which now provides for the inclusion of international students and their dependents within the provincial Health Care Plan.

Appendix A contains a complete list of the active Emerging Issues files during this reporting period.

Systemic Advocacy

The Annual Report updates the progress regarding 11 Systemic Issues which were previously reported. The Office closed one Systemic Issue file - Notification of Parents Following an Interview. This file concerned the policy regarding notification of parents whose children had been interviewed in child protection referrals. The policy has been revised and now stipulates that parents are to be notified the same day the interview occurs.

Reviews/Investigations

The Child and Youth Advocate provided notice to the Deputy Minister of Health and Community Services and the Chief Executive Officer of the Eastern Regional Integrated Health Authority of its intention to conduct a Review of government programs and services provided to an infant who had been malnourished and subsequently admitted to hospital while the family was in receipt of services from the Eastern Regional Integrated Health Authority.

Notice was also provided to the Deputy Minister and to the CEOs of the four Regional Integrated Health Authorities of the intention of the Office to conduct a Review of "The Transitioning of Children and Youth in Care in the Province", which involved a Review of services provided to children who were in the care of the Director in the Region and were subsequently moved to another placement during the time period January 1, 2006 to December 31, 2006.

The two Reviews of government programs and services identified in the previous Annual Report are still ongoing.

The Turner Child Death Review/Investigation Report completed by Dr. Peter Markesteyn was publicly released on October 4, 2006.

Details regarding these Reviews are provided in the Reviews/Investigations Section of this Annual Report.

Advocacy Services in Labrador

The Office continued its individual advocacy work on behalf of children and youth in Labrador. In addition, meetings took place with Aboriginal Leaders and various Board and Government officials regarding issues which had been brought to the attention of the Office.

Public Education

The Office continued its mandate with respect to educating the public about the role of the Office and promotion of the awareness of the rights of children and youth. 128 meetings/presentations were held with youth groups, students, community groups and community members - an increase from 82 meetings/ presentations last year and 72 meetings were held with Government Departments, Boards and Agencies - an increase from 43 meetings last year. Twenty-one interviews were conducted by the Child and Youth Advocate with the media. Appendix B contains a complete listing of meetings, presentations and media interviews.

Types of Referrals

For the purposes of reporting, the types of referrals recorded include four main categories:

Individual Advocacy

Individual Advocacy includes the provision of information, self-advocacy, basic and comprehensive advocacy services. Individual Advocacy differs depending upon the type of intervention provided.

- Information involves the provision of information and/or referral to another government department, board, or agency.
- another government department, board, or agency.

 Self-Advocacy Assistance involves the provision of information regarding programs, services, appeal procedures, options, and strategies, and may include coaching.
- Basic Advocacy Intervention involves the provision of advocacy services requiring consultation and/or referral to other agencies and is usually completed within a short time frame. Advocacy staff engage in problem-solving strategies; make initial calls to service providers; and provide self-advocacy assistance.
- Comprehensive Advocacy Intervention involves the provision of intensive advocacy intervention when basic advocacy intervention and/or self-advocacy assistance is not sufficient. Comprehensive Advocacy Intervention may involve in-depth self-advocacy coaching; meetings with multiple service providers; meetings with the child/youth and/or his or her natural advocate; attending/arranging case conferences/meetings; and engaging in alternate dispute resolution processes.

II. Emerging Issues

Emerging issue files relate to issues that appear to be impacting a group(s) of children/youth, but require further research to determine if the issues are systemic. Often, individual files highlight emerging issues which require further advocacy work. If an emerging issue is determined to be systemic, the emerging issues file is closed, and a systemic file is opened.

III. Systemic Advocacy

Systemic issue files are opened when issues presented to the Office of the Child and Youth Advocate impact a group(s) of children/youth and, therefore, require advocacy from a systemic perspective.

IV. Reviews/Investigations

Reviews and investigations are carried out pursuant to Section 15. (1) (a) and (c) of the Child and Youth Advocate Act. The Child and Youth Advocate and the any review or investigate a matter on behalf of a child or youth, or group of them, whether or not a complaint has been made and may conduct an investigation if advocacy, mediation, or another dispute resolution process has not resulted in an outcome satisfactory to the Advocate.

For the reporting period from April 1, 2006 - March 31, 2007, the Office of the Child and Youth Advocate opened a total of 739 new files. Added to the 129 files carried over from the Fiscal Year April 1, 2005 - March 31, 2006, the Office dealt with a total of 868 files in the Fiscal Year April 1, 2006 - March 31, 2007.

Table 1 details the nature of these files, the number of files opened, closed, and carried over to the Fiscal Year April 1, 2007 - March 31, 2008.

Individual Advocacy File Statistics April 1, 2006 - March 31, 2007

The statistical information collected from Individual Advocacy files provides a demographic profile of the client group served by the Office of the Child and Youth Advocate, the nature of referrals received, and the outcomes of advocacy interventions. The statistics in this section are provided in terms of percentages of the 732 individual advocacy files opened in Fiscal Year 2006-2007 and provide information pertaining to the following:

- The Region of the Province in which the child/youth is living.
- The relationship of the caller to the child/youth whom the referral concerns.
- The child/youth's living situation, i.e., with whom the child/youth is living.
- The age of the child/youth experiencing the difficulty.
- The Department/Agency which the referral concerns.
- The specific nature of the referral.

As indicated in Table 1, between April 1, 2006 and March 31, 2007, the Office opened a total of 732 individual advocacy files - an average of 61 individual files per month.

732 Individual issues files were opened by the Office of the Child and Youth Advocate in Fiscal Year 2006 - 2007. 71.7% of these referrals were from the St. John's Metropolitan Area and Eastern Region. The other four Regions are responsible for the remaining 27.7%, while .6% originated from outside the Province.







Education

Case Example: Provision of School Bussing When Child Resides Less Than
1.6 Kilometres from Neighbourhood School

Background

The Office was contacted by parents who expressed concern and frustration over the unavailability of school bus transportation for their seven-year-old son. The child resided less than 1.6 kilometres from school and was therefore ineligible for school bus transportation under the Department of Education School Bus Transportation Policy. The Policy stipulated that the District will only provide transportation to students who reside a distance of 1.6 kilometres or more from their zoned, neighbourhood school.

In this situation, the child's mother had a disability that prevented her from walking even short distances and the father's work schedule prevented him from taking his child to school. This situation resulted in the mother becoming increasingly overwhelmed and depressed at not being able to meet the education needs of her son. The child had missed several weeks of school as a result of these challenges.

Intervention Provided

Advocacy staff became involved due to concern for the child's right to an education and the parents' inability to provide for their son's education needs. The Office was also concerned regarding the impact that his mother's increased anxiety levels and the inability to attend school were having on the child.

A review of the family's finances by the Office indicated that they could provide the necessary financial support to obtain transportation for their son and that their income would not qualify as an exception to the 1.6 kilometre policy.

At the request of this Office, Child, Youth and Family Services (CYFS) completed a risk assessment and determined that provision of funding for a taxi service was an appropriate response to the family's circumstances. CYFS provided an indefinite commitment to the child which included provision of funding until a more appropriate solution was found. Advocacy staff

will continue to provide ongoing support until a permanent solution has been found to ensure that the child attends school.



Section 2 Individual Advocacy (confd)

Justice

Case Example: Independent Legal Representation for Children in Custody/Access Cases

Background

The Office was contacted by the mother of two children, ages 11 and 12. The mother expressed concern that her children were not being heard by Child, Youth and Family Services (CYFS). The parents had made Application to the Unified Family Court regarding custody and access of their two children. Part of the current Court Order stipulated that the mother's access was to be supervised by CYFS.

The mother advised the Office that the visits had been ongoing for over a year without incident and that the children no longer wished for the visits to be supervised.

Intervention Provided

Although Family Court matters are outside the mandate of this Office, the Office was successful in advocating for the children to obtain independent legal representation to ensure that their views were made known to the Court.

Health and Communty Services

Case Example: Delay in Access to Addictions Services and Methadone Maintenance Program

Background

The Office was contacted by the mother of a sixteen-year-old girl who was attempting to enroll in the Methadone Treatment Program. The program had a long wait list and the youth was number 81 on the list. The program did not have any procedures to accommodate exceptions to the wait list and individuals were enrolled on a first-come, first-served basis. Additionally, no screening or assessment processes were in place. The mother was also attempting to get an appointment for her daughter to see an Addictions Counsellor at the Regional Integrated Health Authority and was advised there was a three-month waiting list. The youth was willing and interested in receiving services which she required on an urgent basis.

Intervention Provided

The Office contacted Addictions Services, Regional Integrated Health Authority, who were



able to assess the youth on Intake regarding admission to the Adolescent Day Program, even though that program was still in the process of being established and was not fully operational. The Addictions Counsellor successfully advocated for the youth to be enrolled in the Methadone Treatment Program.

In addition to responding to individual cases, issues related to addictions services are pursued by the Office from a systemic perspective. The need for improvement in this area has been highlighted by the Office in its Annual Reports which are tabled in the House of Assembly.

Case Example: Child Care Support

Background

A 17-year-old pregnant youth contacted the Office with concerns about her capacity to provide for her child. She had been living with her boyfriend's parents due to conflicts experienced while living with her parents, and now both the youth and her boyfriend were attempting to obtain financial assistance and accommodations through the Youth Services Program.



Intervention Provided

Advocacy staff contacted Youth Services in the Region,

who informed this Office that they had applied their risk screening tool and that the youth did not qualify as a child in need of protection. Under the Youth Services Program, a youth must demonstrate that he/she does not have the option of returning home and that there is no one who can provide support on behalf of the youth. In this case, the youth's immediate family was accepting of her returning home and could provide the youth with some supportive services. Therefore, under Youth Services, a request for independent accommodations could not be granted.

However, the Office was successful in advocating to Youth Services for a drug card, medical transportation costs, and support to offset the cost of child care to enable the youth to return to school once the baby was born. In addition, advocacy staff contacted several non-profit organizations in the area and were successful in securing a crib and car seat through a regional community organization.

Case Example: Youth requesting to be placed in an Independent Living Arrangement (ILA) in his home community

Background

The Office was contacted by a youth who was residing in an Emergency Placement Unit (EPU) in St. John's. He had learned about the Office from one of the staff at the EPU. The youth was frustrated because he had been moved from his home community and placed in St. John's after his previous placement had broken down. The youth expressed concern as he had not been involved in, or made aware of, any planning regarding his placement following the mandatory discharge after 60 days from the EPU. The youth was frustrated that his desire

to return to an Independent Living Arrangement (ILA) in his home community was not being taken into consideration by Child, Youth and Family Services (CYFS).

Intervention Provided

A letter was sent to CYFS on behalf of the youth outlining his views regarding his long-term placement. Several case conferences, with participation by the youth, were held. An ILA was set up in the youth's home community.

Section 2 Individual Advocacy (contd)

Health and Community Services

Case Example: Inter-Provincial Child Protection Referrals

Background

The Office was contacted by a parent who was concerned because his ex-partner had recently fled Newfoundland for the province of Québec, taking their 16-month-old child with her. The father further advised that the child's mother had a history of suicidal tendencies and was suffering from Post-Partum Depression. He also noted that his ex-partner had recently disclosed to him that she had had dreams about killing herself and their child. The father had reported all of this information to Child, Youth and Family Services (CYFS); however, he claimed that CYFS had not made a child protection referral to Centre Jeunesse (Child Protection Services in Québec).

Intervention Provided

The Office provided the father with the contact information for Centre Jeunesse and insisted that he immediately make a referral to that agency. The Office followed up with an independent referral to ensure that the informa-

tion was received. Upon making the referral, Advocacy staff were referred to the Centre Jeunesse worker who was assigned to the file. The worker explained that she had received the father's referral and commenced a risk assessment. However, she also noted that she had not yet been contacted by CYFS and required information regarding their involvement with this family. Advocacy staff then proceeded to contact CYFS and inquired why they had not yet contacted Centre Jeunesse. CYFS explained that a referral had in fact been made: however.

the referral was made to a senior level of administration at Centre Jeunesse. Advocacy Staff requested that CYFS make direct contact with the Centre Jeunesse worker assigned to this family. Shortly thereafter, the Office was contacted by the Centre Jeunesse worker who confirmed that she had been contacted by CYFS.

Over the course of the 2006-2007 year, the Office received a number of referrals concerning inter-provincial child protection referrals. Advocacy Staff have responded by obtaining from CYFS the Provincial/Territorial Protocol on Children and Families Moving Between Provinces and Territories. This is a federal/ provincial/territorial document which provides guidelines for inter-provincial child protection referrals and was drafted collaboratively by the Directors of Child Welfare from each respective province and territory. Advocacy Staff have reviewed this document and will utilize it in ongoing individual advocacy work. The Office recommends that the referring agency follow up to ensure the senior officials in the reciprocating province inform their front-line staff immediately when inter-provincial child protection referrals are made.

Case Example: Transitioning of a Youth in Foster Care

Background

Child, Youth and Family Services (CYFS) requested that this Office provide input regarding the transition of a 13-year-old youth with Fetal Alcohol Spectrum Disorder (FASD) and an Anxiety Disorder from his current foster home placement of four years to a new foster home. CYFS informed the Office that they had protection concerns with the current caregivers and had decided that it was in the youth's best interests to be moved to a new foster home.

The Office expressed concern regarding the planned removal of the youth from people he considered family. The Office provided recommendations to CYFS regarding what constituted appropriate transition and post-transition plans for this youth. Although CYFS addressed many of our concerns, they did not ensure the youth's participation in the transition process. We expressed the view that youth have a right to participate in decisions which significantly impact their lives. The non-participation by this youth and the manner in which he was informed

he was to be moved (he was informed during a visit with his social worker he was being moved that same day), was extremely disturbing to this Office.

After the transition, we met with the youth and he expressed upset and frustration over his lack of involvement in the decision to remove him from his "family" and the fact that he had not been made aware of the planned move prior to the day he was moved. He

was advised by CYFS that, as a youth under the care of the Director, his consent or contribution to the decision was not required. He requested that the Office help him explore options for returning to his foster home.

Intervention Provided

The Office agreed to pursue advocacy efforts on behalf of the youth. Over a period of several months, a number of professionals and service providers were consulted regarding this process. This Office supported the youth throughout the transition and post-transition period, facilitated contact with previous caregivers, and arranged meetings between the youth and CYFS to discuss future decisions that affected his well being. In addition, the Office advocated for legal representation for the youth and was successful in this effort.

CYFS retained an external consultant to complete a file review of this case and to determine appropriate measures related to the transition process. The report supported the decision of CYFS to move the youth, but acknowledged that the transition process was challenging for all involved. The Office continues to support this youth through the post-transition process.



The Office continues to provide individual advocacy assistance to children and youth in care who are transitioned. A Review of the Transitioning of Children and Youth in Care within the Province for the period January 1, 2006 to December 31, 2006 is currently being completed by the Office.

Section 2 Individual Advocacy (contd)

Health and Communty Services

Case Example: Dental Health Services for Children of Families in Receipt of Social Assistance

Background

In the Fall of 2006, the Office was contacted by the parents of a 17-year-old youth who was in need of significant dental work. This youth had one tooth that was fractured at the gum line and several large cavities which were seriously infected. The youth's parents were in receipt of social assistance and were not financially able to pay for the necessary dental procedures. The parents requested the assistance of this Office in accessing approval for the required services through the Newfoundland and Labrador Dental Health Plan.

Intervention Provided

Recent changes to the Newfoundland and Labrador Dental Health Plan impacted the eligibility of children to avail of publicly funded dental health services. Specifically, the new plan covers publicly funded dental care for children up to and including age 12, and extends basic services to age 17 in those cases where a child's family is in receipt of social assistance.

At the time of the referral, the recent changes to the Newfoundland and Labrador Dental Health Plan were in the process of being implemented. Advocacy staff contacted the Office of the Director of Dental Services to confirm the youth's eligibility and to clarify the application procedure that the family was required to complete in order to access the required services. The Director's Office confirmed the youth's eligibility (his parents were in receipt of social assistance) and clarified the application process. Advocacy staff assisted the family in completing the required application, and the youth's dental work was completed a short time thereafter.

Section 4 Reviews/Investigations

Reviews - Section 15. (1) (a) Child and Youth Advocate Act

In the previous Annual Report, it was reported that a Review of government programs and services provided to a family of a woman convicted of charges related to ongoing physical and emotional abuse of children spanning several years would be initiated. Work related to this Review was undertaken during this reporting period, and the Review remains active.

The previous Annual Report also reported that a Review of government services and programs provided to children and youth who were complainants in the Royal Newfoundland Constabulary Police Investigation known as Operation Rescue had been initiated. The Office concluded much of its work related to this Review during this reporting period; however, due to the fact there are criminal proceedings still pending before the Supreme Court Trial Division, the Report cannot be publicly released until all matters before the Court are concluded.

Two new Reviews were initiated by the Office of the Child and Youth Advocate during this reporting period. On August 1, 2006, the Child and Youth Advocate provided notice to the CEO, Eastern Regional Integrated Health Authority, and to the Deputy Minister of Health and Community Services that she intended to

conduct a Review of services provided to an infant child who resided in a community on the Avalon Peninsula. The child had been in receipt of services from the Eastern Regional Integrated Health Authority and had been admitted to hospital suffering from severe malnourishment. Criminal charges were laid against the parents who entered guilty pleas and each received a twelve-month jail sentence. This Review is ongoing and it is anticipated the Report will be publicly released in the Spring, 2008.

The Child and Youth Advocate provided notice of a second Review during this reporting period on November 7, 2006, to the Deputy Minister of Health and Community Services and the four CEOs of the Regional Integrated Health Authorities of her intention to conduct a Review of the Transitioning of Children and Youth in Care within the Province for the period January 1, 2006 to December 31, 2006. The Review will cover the provision of government services and programs, including analysis of the relevant policy and legislation for children who were in care during this particular time and who were transitioned to another placement. This Review is ongoing and it is anticipated that the Report will be released in the Summer, 2008.

Section 4 Reviews/Investigations (contd)

Child Death Review/Investigation

In 2003, the Child and Youth Advocate, pursuant to Section 15 of the *Child and Youth Advocate Act*, commenced an investigation into the death of a thirteen-month-old infant. The Review was delayed due to the illness and subsequent resignation of the former Child and Youth Advocate on March 31, 2005 and was contracted to Dr. Peter Markesteyn in May, 2005.

The current Child and Youth Advocate publicly released the Findings of Dr. Peter Markesteyn in the Turner Child Death Review and Investigation on October 4, 2006.

Dr. Markesteyn made a number of Recommendations which related to the delivery of child protection services within the Province. Dr. Markesteyn identified a number of areas that warranted improvement and recommended changes to policy and legislation with respect to the delivery of child protection services. Key among these recommendations were:

- the need for social worker training in assessment and investigation of protective intervention cases:
- the need for clear policy guidelines to be established for managers/supervisors regarding assistance to social workers in identifying tasks to accomplish goals within specific timeframes, along with procedures for review of outcomes;

- the need for ongoing in-service training for supervisors and direct service personnel;
- the need for improved record keeping and the transfer of all previous child abuse and neglect referrals to CRMS (CYFS computerized file management system).

The Turner Report also contained a key recommendation with respect to the *Child and Youth Advocate Act*, the legislation which establishes the Office of the Child and Youth Advocate. Dr. Markesteyn recommended that the Child and Youth Advocate be granted subpoena powers in order to effectively carry out the mandate of the Office "to protect and advance the rights and interests of children and youth" within the Province.

Follow up by the Child and Youth Advocate to the Turner Report occurred during this reporting period and has included meetings with officials within the Department of Health and Community Services as well as a meeting with the five-member Ministerial Committee established by Premier Danny Williams, Q.C. to review the Turner Recommendations.

Section 5 Advocacy Services in Labrador

The Office continued throughout this reporting period to provide individual advocacy services to children and youth in Labrador.

The Child and Youth Advocate and the Director of Advocacy Services travelled to Nain for Child and Youth Advocacy Week, November 19 to 25, 2006. Meetings were held with the President and the Deputy Minister, Health and Social Development, Nunatsiavut Government; and with staff at the group home, school and Child, Youth and Family Services.

Meetings were held with youth who were living at the Martin Martin Group Home and with youth attending Jens Haven School.

On February 6, 2007, the Child and Youth Advocate and the Director of Advocacy Services met with Chris Montague, President, and Bert Pomeroy, Executive Assistant, of the Labrador Métis Nation regarding issues affecting Métis children and youth in Labrador.

A week-long advocacy clinic was conducted in Hopedale in March 2007 by the three frontline Advocacy Services Specialists. Meetings were held with youth and staff at the Community Youth Network, as well as with members of the local RCMP detachment and staff of Child, Youth and Family Services and Health and Social Development. Staff also met with members of the Town Council and the Chair of the Hopedale Arena Committee.

The Office plans to increase the number of advocacy clinics in Labrador in the coming year. Further discussions are planned with Aboriginal leaders and regional service providers regarding the gaps in the services available to children and youth in Labrador.

The Office has initiated a Review of the Transitioning of Children and Youth in Care within the Province for the period January 1, 2006 to December 31, 2006. This Review will examine the provision of government services and programs, including analysis of the relevant policy and legislation for children who were in care during this particular time and who were transitioned to another placement. Given the severe shortage of available foster placements in Labrador and the number of children from Aboriginal communities who have been placed outside the Province, it is hoped that this Review will support recommendations regarding the Government action required to address the issue. It is anticipated that the Review Report will be released in the Summer 2008.

The Office looks forward to increasing its presence in Labrador and to continuing to advocate for improved services for the children and youth in Labrador.

Section 6 Public Education

Advocacy Clinics/Regional Visits 2006-2007

During the Fiscal Year April 1, 2006 - March 31, 2007, staff of the Office conducted Advocacy Clinics in various Regions of the Province and met with children and youth, child-and-youth-serving agencies, community groups and government officials.

These Regional visits provided staff with valuable first-hand accounts of challenges being experienced by children and youth in accessing government services and programs.

Media Interviews

The Child and Youth Advocate conducted a total of 21 interviews with the media, which provided opportunities to highlight the work of the Office, as well as the issues affecting children and youth in the Province.

Child and Youth Advocacy Calendar Project

For the third year, the Office invited schools across the Province to participate in the Child and Youth Advocacy Calendar Project by submitting artwork entries depicting this year's theme "Our Rights = Our Future". The Office received several excellent artwork submissions, from which twelve were chosen for inclusion in the 2007 Child and Youth Advocacy Calendar.

The twelve children whose artwork was included on the calendar received a sports bag with the Office logo and their names printed on it and a copy of the calendar. Other entries were highlighted on the Office website and are displayed in this Report.

"Sharing Our Cuttures" Mutticuttural Fairs

During this past year, Advocacy staff had an opportunity to participate in two "Sharing Our Cultures" Multicultural Fairs. The first Fair took place on May 7 and 8, 2006 in Clarenville and Random Island. It was the first time that the Fair was held outside St. John's. Students from the Region, as well as representatives from youth-serving community agencies and government attended.

The second "Sharing Our Cultures" event took place in St. John's from March 25 to 27, 2007 and was attended by approximately 1500 students as well as representatives from youth-serving agencies and government departments.

The Multicultural Fairs present a unique atmosphere for students and community members to explore the cultures of other parts of the world while also learning about the services and programs that exist within the Province. These events also provide Advocacy staff with opportunities to connect with youth and to share information about the role of the Office.



Extrajudicial Sanctions Annual General Meeting 2006

On October 21, 2006, Alex Chernoff, Advocacy Services Specialist, presented on behalf of the Office of the Child and Youth Advocate at the Extrajudicial Sanctions Annual General Meeting held in Grand Falls-Windsor. The two presentations were attended by over 50 professionals, including social workers, public health nurses, lawyers, police officers, youth correctional officers, and community volunteers.

Section 6 Public Education (confd)

Child and Youth Advocacy Week

Proclamation

On October 31st, 2006, Premier Danny Williams, Q.C., proclaimed the week of November 19th to 25th, 2006 as Child and Youth Advocacy Week in the Province of Newfoundland and Labrador. This week was again chosen to coincide with National Child Day, November 20th.

Activities

During Child and Youth Advocacy Week, the Advocate and staff visited Nain, Grand Falls-Windsor, Botwood, Stephenville, Whitbourne and St. John's. There were a number of activities involving children and youth. Some highlights of the week included:

- Participation in National Child Day Celebrations at the Mew's Centre, St. John's. This event provided an opportunity for staff to speak informally with children and families/caregivers and to share information about the role of the Office.
- Suppers and Meetings with Youth in Care/Custody the Advocate and staff hosted suppers and held meetings with youth living in group homes in Nain, Grand Falls-Windsor and Stephenville and with residents at the Newfoundland and Labrador Youth Centre, Whitbourne. Youth were encouraged to discuss any concerns they had regarding access to services. In addition, the Advocate and staff provided information to these youth about their rights and the role and mandate of the Office.
- Other activities included visits to schools in Nain, Grand Falls-Windsor and Stephenville; visits to Family Resource Centres in Grand Falls-Windsor and Botwood; meeting with the Nunatsiavut Government, Nain; and meeting with staff of Child, Youth and Family Services, Labrador-Grenfell Regional Integrated Health Services, Nain.

Distribution of Posters, Brochures, Advocacy Calendars, and Promotional Items

The Office of the Child and Youth Advocate continued to provide information regarding the rights of children and youth and the role of the Office to children and youth, community child/youth-serving agencies, and government officials through the Office's promotional materials (brochures, advocacy calendars and posters).

During the past year, the Office also developed a new banner which focuses on the rights-based perspective of the Office. This banner will be used by staff as a promotional tool when they represent the Office at events such as multicultural fairs, youth forums, conferences, etc. A bookmark has also been designed which reflects the style and content of the banner. These bookmarks will also be used as promotional aids.

Section 7 Other Activities

"Beyond The Street: Youth and Communities Taking Action on Homelessness" Conference

Advocacy staff participated in the National Conference "Beyond The Street: Youth and Communities Taking Action on Homelessness", which took place in St. John's from September 26 to 29, 2006. The conference was attended by youth who have experienced homelessness as well as representatives from community and youth-serving agencies and highlighted issues and concerns at the national and provincial levels. Participants shared their experiences, initiatives and strategies and developed action plans to take back to their communities. This conference afforded the Office an opportunity to further develop working relationships with other community and youth-serving agencies as well as the opportunity to advance the issues and concerns of children and youth affected by homelessness.

Health and Well Being of Children: An Inter-Professional Education Module Memorial University of Newfoundland and Labrador

The Office of the Child and Youth Advocate was invited by the Centre for Collaborative Health Professional Education of Memorial University of Newfoundland and Labrador to participate as a Committee Member of the education module for The Health and Well Being of Children.

The Director of Advocacy Services assisted in the development and delivery of the Health and Well Being of Children education module during the 2007 winter semester at Memorial University. Students from the Schools of Medicine, Nursing, Pharmacy and Social Work participated in a webbased inter-professional education tutorial as well as a face-to-face small group case session, followed by a panel discussion.

The Director of Advocacy Services co-facilitated the web-based tutorials and the panel discussion along with an inter-professional committee comprised of faculty and community members. The education module was evaluated and students reported that the module enhanced their understanding of other professionals' roles and the importance of inter-professional team work.

Canadian Commission for UNESCO -47th Annual General Meeting

Alex Chernoff, Advocacy Services Specialist, participated in the Canadian Commission for United Nations Educational, Scientific and Cultural Organization's (UNESCO's) Annual General Meeting, Linking Networks, Sharing Ideas, which took place in Ottawa from March 15 to 17, 2007. The role of the Canadian Commission for UNESCO is "to act as a forum for governments and civil society, and to mobilize the participation of Canadian organizations and committed individuals in UNESCO's mandated areas: education, natural and social sciences, culture and communication and information."

As part of his participation in the event, Alex was tasked as the Rapporteur for the workshop: Understanding the Impact of Climate Change on Northern Communities in the Context of the International Polar Year. Several of the workshops, such as the Achieving Education For All Through Partnerships workshop, were very useful in providing knowledge and resources which will assist the Office in its ongoing rightshased education initiatives.

Provincial Child and Youth Care Conference

Advocacy staff attended the Provincial Child and Youth Care Conference in St. John's from June 29 to 30, 2006. The conference was hosted by the Child and Youth Care Association of Newfoundland and Labrador and brought together presenters from a variety of backgrounds in the interest of children, youth, and families.

The Child and Youth Advocate gave a presentation at the opening night of the Conference regarding the role and mandate of the Office.

The conference provided an opportunity for child and youth care practitioners and other professionals who work with children, youth and families to come together in an effort to network and share their experiences. The Office of the Child and Youth Advocate was pleased to have the opportunity to participate in such a worthwhile and educational event.

Round Table Discussion on Homelessness and Runaways

As a result of concerns identified through individual advocacy work, on November 27, 2006 the Office hosted a Round Table Discussion on the issues of homelessness and runaways.

Discussion at the Round Table, which was attended by a number of youth-serving agencies, centred on the fact that these issues are affecting children under the age of 16 in the St. John's area and while some services are available, these services and the current responses of service providers are not meeting the needs of youth in this area.

The Office agreed to take the lead on these issues, and a second Round Table Discussion was held on January 31, 2007. At that time, strategies and proactive alternatives were discussed and sub-groups were formed to develop protocols for use by service providers.

Newfoundland and Labrador Youth Centre Team Meetings

During this past year, the Office of the Child and Youth Advocate was invited to participate in the Newfoundland and Labrador Youth Centre Team Meetings, which are organized periodically to discuss emerging issues, review current practices and ongoing initiatives at the Centre. In addition to the staff of the Centre, a number of community professionals affiliated with the Centre attend these meetings, including psychiatrists, clinical psychologists, public health nurses, guidance counsellors, and social workers.

Two Advocacy staff attended the Team Meeting that was held in South Dildo on September 16, 2006 and presented on the role of the Office.

The Office will continue to provide input and advocate for improved services for youth serving secure custody sentences and, in particular, access to services and programs by youth at the Centre, including community reintegration supports.

Child Rights Information Network (CRIN)

In January, 2007 the Office became a member of the Child Rights Information Network (CRIN). CRIN is an organization which operates a global network that disseminates information about children's rights among non-government organizations, United Nations' Agencies, International Government Organizations, Children's Commissioners Offices, Educational Institutions, and other child rights experts worldwide, in order to promote the implementation of the *United Nations Convention on the Rights of the Child* world wide. CRIN has a membership of over 1,700 organizations in over 140 countries.

Membership in this Network enables the Office to liaise with other child rights professionals, to access information on children's rights, and to share information with other member organizations
