BY-ELECTION SUMMARY

On Tuesday, August 21, 2018, Cathy Bennett, Liberal Member for the electoral district of Windsor Lake, resigned her seat resulting in a vacancy in the House of Assembly.

A proclamation was issued on August 22, 2018 pursuant to Order in Council Number 2018-163 and the Chief Electoral Officer issued a writ of election to the Returning Officer, Mr. James Langor.

The by-election date was set for Thursday, September 20, 2018. The following key dates and deadlines were in effect for the by-election:

Official Addition of the Votes

At the time of the by-election call, the distribution of seats in Newfoundland and Labrador was: 27 Liberals, two New Democrats, seven Progressive Conservatives, three Non-Affiliated and one vacancy.

The distribution of votes during the by-election was as follows:

- 3,163 votes cast at the Regular Polls
- 1,439 votes cast at the two Advance Polls
- 171 Special Ballot Votes were received at Elections NL by the specified deadline

Mr. Ches Crosbie, Progressive Conservative candidate, was declared elected as the Member of the House of Assembly for Windsor Lake.

Expenditures on the Windsor Lake by-election were \$129,060. Salaries and wages to Election Officials accounted for \$59,240 of the expenditures. \$37,270 was for purchased services and other election expenses. Grants and Subsidies totaled \$32,550.

PROCEDURAL AND ADMINISTRATIVE CHANGES IN EFFECT FOR THE WINDSOR LAKE BY-ELECTION

1. Additional Special Ballot Officer at District Office

With the goal of elevating the level of efficiency at the district Returning Office, a second Special Ballot Officer position was added to the staff complement to assist with: processing Special Ballot Applications, and to meet the increased demand for home visits and administrative support for the Returning Officer. The addition of the position proved beneficial to the office.

2. Reporting the Election Night Count

Elections NL introduced a new method of reporting the election night count to improve the efficiency and accuracy of election night results at the district level. In past General Elections and by-elections, the Returning Officer and the Election Clerk verified and reported the polling division counts to Elections NL headquarters in cumulative five poll totals. This procedure often resulted in delays and errors in addition in reporting the results.

For the Windsor-Lake by-election the recording and reporting of vote counts was conducted electronically from the Returning Office. This new method eliminated the need for the Returning Officer to call Elections NL's headquarters to report cumulative totals. Vote counts by polling division's Deputy Returning Officer were reported to the Returning Office by telephone and were entered into the system. After the numbers were verified, they were submitted live to the Elections NL website. This new method worked with ease and was viewed by district office staff and by Elections NL's headquarters staff as being very efficient and will continue to be used in future events.

3. Second Day of Advance Poll Voting Added

Continuing with the success of a second day of Advance Poll Voting used in the November 21, 2017 by-election in Mount Pearl North, a second day of Advance Poll voting was also implemented for Windsor Lake.

BOUNDARIES AND POLLING STATIONS

The boundaries for Windsor Lake were the same as those used in the 2015 Provincial General Election. There were a total of 38 polling divisions in the district comprised of 33 regular polling divisions, four Advance Polls and one Special Ballot poll. There were some minor reconfigurations to some polling divisions since 2015. A listing of the polling divisions and their boundary descriptions (Appendix A), along with a map of the electoral district showing the polling division boundaries (Appendix B), are included in this report.

ELECTION OFFICIALS

The Returning Officer, who manages the election at the district level, appoints an Election Clerk and Special Ballot Officer(s). Together, they work in the district Returning Office to help administer the by-election.

The Returning Officer is also responsible for hiring and training all election officials for their district. This includes everyone who will work in the polls: Deputy Returning Officers, Poll Clerks, Supervisors, Door Guards, Messengers, Witnesses and Special Ballot Officers.

CANDIDATE REGISTRATION AND NOMINATION

At the time of the by-election, there were three registered parties in the province: the Liberal Party, the New Democratic Party and the Progressive Conservative Party. Each of the three registered parties put forward a candidate by the 2:00 p.m. deadline on Thursday, August 30, 2018.

METHODS OF VOTING

SPECIAL BALLOT VOTING: ENL HEADQUARTERS AND DISTRICT OFFICE

Special Ballot applications were available to electors on the Elections NL website, by mail, at Elections NL headquarters in St. John's, and at the Windsor Lake district Returning Office.

Elections NL headquarters and the district Returning Office began accepting Special Ballot applications from the date of the writ issue (Wednesday, August 22) to the application deadline of 6:00 p.m. on Saturday, September 15, 2018.

Beginning on Friday, August 31, 2018, electors were able to vote by Special Ballot by mail or in person at the district Returning Office and at Elections NL headquarters. Once a Special Ballot application was approved, a Special Ballot voting kit was issued and the applicant was considered to have voted.

A completed Special Ballot voting kit could be returned by mail or dropped off at either the district Returning Office or at Elections NL's headquarters by the applicable deadlines specified in the by-election calendar.

Two extra days were provided at both Elections NL's headquarters and at the district Returning Office to allow for the timely return of completed Special Ballot kits. Administrative deadlines must be in place and adhered to in order to provide sufficient time for the application to be completed and approved, and to allow adequate time for the ballots to be returned by mail or in person in time for counting. The deadline for receipt of a completed Special Ballot kit was Monday, September 17 at 4:00 p.m.

A total of 176 special ballot applications were processed. None of the Special Ballots were rejected and five Special Ballots were not returned to Elections NL headquarters in time for the Special Ballot count procedure resulting in a total of 171 special ballot votes counted. Comparatively, in the 2015 General Election there were 194 electors who voted by Special Ballot in the district.

SPECIAL BALLOT VOTING: HOSPITALS

Special Ballot voting was offered to Windsor Lake residents in four hospitals on Wednesday, September 12 and in one Personal Care Home on Thursday, September 13.

A representative from Elections NL and a facility representative arranged for the hospital visitations and two appointed Special Ballot Officers conducted the vote. The hospital vote resulted in a total of six cast ballots.

SPECIAL BALLOT VOTING: PERSONAL CARE HOMES

A representative from Elections NL, the district Returning Officer and a facility representative arranged the vote in one Personal Care Home in St. John's. Two appointed Special Ballot Officers conducted the vote. The Personal Care Home vote resulted in a total of 27 cast ballots.

ADVANCE POLL

Advance Poll voting was held in the Windsor Lake district on Thursday, September 13 and Saturday, September 15, both days from 8:00 a.m. to 8:00 p.m. Advance Voting took place in two buildings, which each had two polling stations (for a total of four Advance Polls):

- Macdonald Drive Junior High (110 MacDonald Drive, St. John's)
- Roncalli Elementary School (130 Airport Heights Drive, St. John's)

The preliminary list of electors was certified on August 22, 2018 and contained 9,077 registered electors. The list was manually updated with electors who registered with Elections NL after August 22, 2018. Electors who choose to vote by Special Ballot were also struck from the list previous to the first day of Advance Poll voting on Thursday, September 13, 2018. A second, updated list of electors was certified on September 14, 2018. This list contained additional revisions and updates resulting from Special Ballot voting and the first day of Advance Poll voting and contained 9,122 electors. This list was used on the second day of Advance Poll voting which was Saturday, September 15.

Seventeen election officials were hired, trained and employed for the Advance Polls.

The Advance Poll results were as follows:

- 684 votes cast on the first day of Advance Poll voting (Thursday, September 13, 2018)
- 755 votes cast on the second day of Advance Poll voting (Saturday, September 15, 2018)
- 1439 total votes cast (two Advance Polls combined)
- Two rejected ballots (which resulted in a total of 1,437 valid ballots)

Comparatively, during the 2015 Provincial General Election there were 889 votes cast during one day of Advance Polling in the district of Windsor Lake, with four rejected ballots for a total of 885 valid votes cast.

BY-ELECTION DAY

Regular poll voting took place on Thursday, September 20 from 8:00 a.m. to 8:00 p.m. at 33 polls in five different locations:

- Best Western Plus (34 Jetstream Avenue, St. John's)
- Macdonald Drive Junior High (110 MacDonald Drive, St. John's)
- Holiday Inn (180 Portugal Cove Road, St. John's)
- Roncalli Elementary School (130 Airport Heights Drive, St. John's)
- MacMorran Community Centre (10 Brother McSheffrey Lane, St. John's)

There were 4,763 valid ballots cast in the by-election. This compares with 4,799 valid votes cast in the 2015 Provincial General Election.

ELECTOR PARTICIPATION

The preliminary list of electors for Windsor Lake, certified by the Chief Electoral Officer on August 22, 2018, contained a total of 9,077 registered electors.

A revision period took place from Thursday, August 23 to Saturday, September 15. During this period, electors were verified, updated, removed or added to the list as a result of various revision activities. Revision activities during this period included swear ins from two days of Advance Poll voting, as well as Special Ballot voting at Personal Care Homes, hospitals, the district Returning Office and at Elections NL's headquarters. In addition, Elections NL included elector updates received from the City of St. John's 2017 Municipal Election.

Voter information cards (VICs) were mailed to each elector on the preliminary list of electors prior to the beginning of the revision period. The distribution of these cards prompted calls to Elections NL to verify, update, remove or add elector records. There were 59 VICs returned to Elections NL headquarters during the revision period and Elections NL was able to confirm that these electors no longer resided in the district and were removed from the district voters list. After all revisions and updates were

made to the list there was a total of 59 electors removed from the list and 91 electors added to the final revised list of electors used on polling day for a total of 9,109 electors.

The table below illustrates voter turnout in by-elections over the last 10 years. 'Eligible Voters' below includes the total number of eligible electors on the Final List of Electors for that particular electoral event, as well as any swear ins that took place at the polls. Note that voter turnout is rounded to the nearest tenth of a percent.

OFFICIAL ADDITION OF THE VOTES

In accordance with s. 153 of the *Elections Act, 1991*, the Official Addition of the Votes takes place three days after polling day. In the case of the Windsor Lake by-election, the Official Addition took place on Sunday, September 23, 2018 at 9:00 a.m. at the Returning Office in the presence of two required witnesses.

During the official addition process, the Returning Officer removes the Official Statement of the Poll sheets from each district ballot box and reviews them to ensure the accuracy of the calculation of vote totals.

The conclusion of the Official Addition of the Votes declared the Progressive Conservative candidate, Ches Crosbie, elected.

RETURN OF THE WRIT


Section s. 163(1) of the *Elections Act, 1991* requires a waiting period of 12 clear days between the conclusion of the official addition and the return of the writ of election. This provides sufficient time for a candidate, voter or district officer to request a judicial recount. A recount was not requested in the Windsor Lake by-election. As a result, the writ of election was returned to Elections NL on Monday, October 8, 2018 and the Progressive Conservative Candidate, Mr. Ches Crosbie, was sworn in on Friday, October 12, 2018.

OBSERVATIONS OF THE CHIEF ELECTORAL OFFICER

STAFF HIRING FOR DISTRICT OFFICE, POLLING STATIONS AND AT ELECTIONS NEWFOUNDLAND AND LABRADOR HEADQUARTERS

An estimated 3,700 polling day workers are required to administer an election province wide on polling day. Currently, sections 21(3) and 22 of the *Elections Act, 1991* ('Act') restrict Elections NL from hiring Election Day workers under the age of 18 years or persons in the employ of a department of the government of the province or the Government of Canada. This restriction greatly impacts the

ability of Elections NL to grow its workforce, implement technology, and deprives the youth of our province the opportunity to actively participate in current affairs and engage in civic life.

Elections NL fully understands what the positive impacts of removing the restrictions on poll workers would mean for electoral administration. Allowing federal and provincial employees and youth aged 16 and 17 to work at a polling station creates a broader pool of candidates to choose from resulting in a greater wealth of knowledge and experience in the poll and contributes to an overall positive experience for the elector. Allowing youth employees at the polls would strengthen the youth voice and acknowledge that their opinion matters. Studies have shown that engaging youth employees would guarantee a supply of young voters needed to support a democratic society. From an administrative perspective, federal and provincial employees and most youth have a technology capacity that is above average and would meet Elections NL's requirements as the office strives to innovate and find efficiencies in the electoral process while meeting the standards expected by our primary stakeholder – the elector.

SPECIAL BALLOTS: VOTING AT PERSONAL CARE HOMES

Rather than the blank, write-in Special Ballot, a regular ballot with the names and political parties of the candidates was used for the Special Ballot vote at Chancellor Park. The use of a regular ballot, which was also implemented with the Personal Care Home vote in the Mount Pearl North by-election, was well received by electors who voted by Special Ballot. It also makes the counting and scrutinizing of the Special Ballots easier when the Special Ballot count procedure was conducted. It also lessens the rate of rejected ballots since electors are only required to mark an 'x', as opposed to having to print the name of the candidate and the name of the political party of the candidate on the blank, write-in Special Ballot (as required in the *Elections Act, 1991*).

ADVANCE VOTING DAYS

Elections NL has observed that the proportion of votes cast at Advance Polls during electoral events is continually increasing. Similar to the Mount Pearl North by-election, the Chief Electoral Officer opted to hold Advance Voting for the Windsor Lake by-election over two days to offer additional opportunities for voters to cast their ballot, specifically providing one of those opportunities on a Saturday.

Based on the distribution of votes during the September 20, 2018 by-election, the addition of a second day of Advance Polling was well-received by the electors of the district. Of the 4,773 total votes cast in the by-election, 1,439 votes were cast during the two days of Advance Polls, representing 30.1% of the vote. In contrast, during the 2015 General Election, only 18.4% of votes cast were at the Advance Polls (889 votes of 4825 total votes).

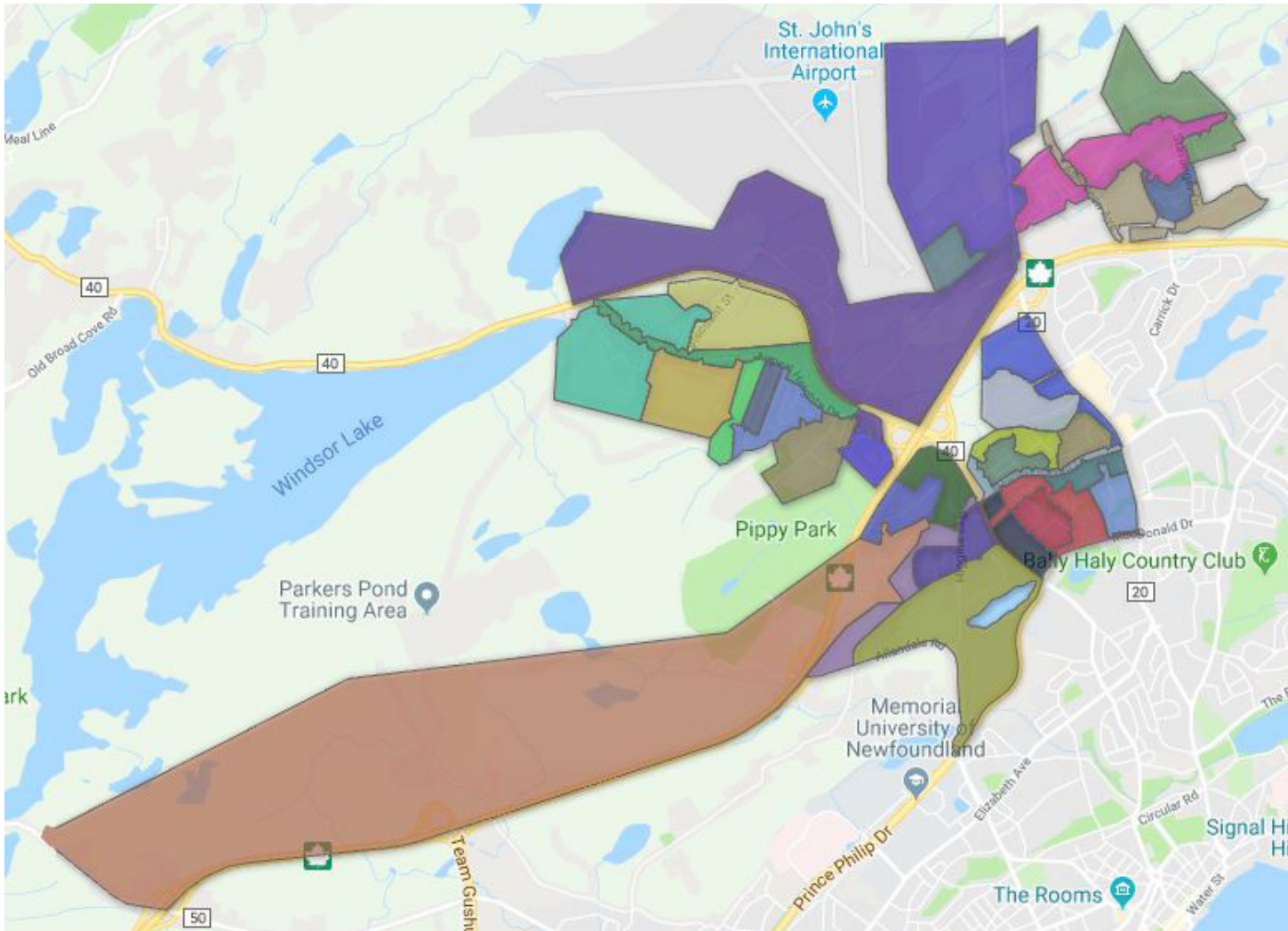
Going forward, the Chief Electoral Officer will continue to provide additional Advance Voting opportunities for electors during by-election campaigns where it is feasible for Elections NL to conduct multiple Advance Voting days. The *Elections Act, 1991*, currently permits Advance polls to be held on one or more of the seven days immediately preceding polling day.
