### **Overview**

The Provincial Advisory Council for the Inclusion of Persons with Disabilities was established in 2009 by the Provincial Government of Newfoundland and Labrador to advance its commitment to inclusion.

The Council shares its expertise and knowledge, advises the Provincial Government on disability-related issues and the removal of barriers to inclusion.

### **Mandate**

The Council's mandate is to advise and inform the Minister Responsible for the Status of Persons with Disabilities on matters concerning persons with disabilities in Newfoundland and Labrador. The Council:

- Brings knowledge and understanding of disability-related issues to the Provincial Government
- Advises the Provincial Government as it develops policies, programs, strategies, and makes recommendations to advance the inclusion of persons with disabilities
- Promotes awareness of the barriers experienced by persons with disabilities

### **Vision**

The Council endorses the vision set out in the Provincial Strategy for the Inclusion of Persons with Disabilities:

Newfoundland and Labrador will be a fully inclusive province where people with disabilities have the same opportunities and choices on an equal basis with others.

# **Physical Location**

The Council does not have an office or physical location. The Council can be contacted through the Disability Policy Office, which is located within the Department of Advanced Education and Skills, 3rd Floor, West Block, Confederation Building, St. John's, Newfoundland and Labrador. The Disability Policy Office acts as secretariat to the Council.

# Representation

The Council has 12 to 18 volunteer members who are appointed by the Minister Responsible for the Status of Persons with Disabilities (the Minister Responsible). The Minister Responsible appoints the Chair of the Council to serve a three-year term and the Council members are appointed for two-year terms. The Council meets up to four times a year, (see Appendix A: Terms of Reference and Appendix B: Council Membership 2013-14).

Council representation consists of an urban-rural balance with regional representation, gender balance and representation of different types of disabilities. New Council members were appointed in February 2014.

# **Primary Clients**

The Council brings knowledge and understanding of disability issues to the Provincial Government and advises government on initiatives to advance the inclusion of individuals with disabilities in all aspects of society. In this capacity, the Council serves its primary client, the Government of Newfoundland and Labrador, by providing advice to the Minister Responsible and other levels of government.

### **Description of Expenditures**

Council members are appointed from the general public and do not receive remuneration. Council members are reimbursed for expenses and travel costs. The travel expenses and costs associated with the work of the Council are covered by the Department of Advanced Education and Skills and are included in its departmental budget.

### **Shared Commitments**

The Council has a commitment to advance inclusion in all aspects of society throughout the province. This means identifying barriers experienced by persons with disabilities, and developing standards to prevent new barriers. Inclusion influences all aspects of an individual's life such as family, community, recreation, education, employment, access to information, access to services and access to opportunities.

This commitment is shared with the Provincial Government through the Provincial Strategy for the Inclusion of Persons with Disabilities and the Convention on the Rights of Persons with Disabilities (the Convention). The Convention promotes and protects all rights and freedoms of persons with disabilities, so that individuals have full participation, dignity and respect to live in society on an equal basis with others.

An inclusive society is a commitment that is expanding to all sectors including private businesses, community groups and other public organizations.

# **Highlights & Accomplishments**

The Council has accomplished a great deal over the period covered by the Activity Plan 2011-2014. By the end of the fiscal year 2013-2014, Council met on numerous occasions with the Minister Responsible for the Status of Persons with Disabilities, officials from a number of departments and agencies, as well as representatives of community organizations, to gain information and provide advice. Some of the initiatives and achievements are outlined below:

- Advised on implementation of the strategy and priority actions, including a multi-media campaign with positive promotion of persons with disabilities; promotion and incorporation of universal design, engaging municipalities throughout the province; accessible electoral processes; legislative review of the *Buildings Accessibility Act*; universal access to disability-related supports; supports for children with disabilities in foster care; supports for living in the community; and incorporation of accessibility and inclusion practices in emergency/evacuation planning.
- Advised on issues of importance to persons with disabilities, including the development of three position statements:
  - Disability-Related Supports Framework
  - Supports for Students with Disabilities (K-12)
  - Supports for Post-Secondary Students with Disabilities
- Developed a three year Activity Plan for 2014-2017. The Activity
  Plan for Council includes activities on advising the Provincial
  Government on the Provincial Strategy for the Inclusion of Persons
  with Disabilities as well as advising the Minister Responsible on
  time sensitive, emergency or systemic issues.

The Council held one meeting in March 2014 with newly appointed and re-appointed members. In addition, a meeting was also held with the Minister Responsible for the Status of Persons with Disabilities to discuss the Provincial Government's commitment to inclusion and the development of an action plan for the Inclusion Strategy.

Council members participated in a networking opportunity with the Minister Responsible and representatives from organizations of and for people with disabilities.

# **Report on Performance**

In its 2011-14 Activity Plan, the Council identified two key activities that supported its mandate and included performance measure information, including measures and indicators. This assists both the Council and the public in monitoring and evaluating the success of the activity plan. The Council was successful in meeting performance objectives in its third year of the 2011-14 Activity Plan.

Council's mandate crosses all Provincial Government departments and agencies. The Council addressed the following strategic direction of the Department's Strategic Plan: "Enhanced inclusion of persons with disabilities in all aspects of society".

The key activities of the Council are:

- 1. Advise the Provincial Government on the design, implementation, monitoring and reporting for the provincial strategy.
- 2. Advise the Provincial Government on issues of importance to people with disabilities that may include advice on time sensitive, emergency, individual and/or systemic issues.

# Activity 1: Provincial Strategy for the Inclusion of Persons with Disabilities 2013-14

The Council was pleased to provide advice on the strategy based on its expertise. This work contributed to the implementation of "Access. Exclusion. Equality, Provincial Strategy for the Inclusion of Persons with Disabilities".

**Objective:** By March 31, 2014, the Council will have advised the Provincial Government on the design, implementation, monitoring and reporting for a Provincial Strategy for the Inclusion of Persons with Disabilities.

**Measure:** The Council advised the Provincial Government on the design, implementation, monitoring and reporting for a Provincial Strategy for the Inclusion of Persons with Disabilities.

Contributed to the development of an action plan to achieve the five strategic directions of the provincial strategy for the inclusion of persons with disabilities.

The Council provided advice on the development of an action plan and identified priority areas to support each of the five strategic directions in the strategy. These included:

### Strategic Direction #1

 Ensure positive promotion of persons with disabilities through a multi-media campaign

### **Strategic Direction #2**

- Engage municipalities throughout the province in inclusion initiatives;
- Ensure all voting booths and electoral information is accessible

### **Strategic Direction #3**

- Update buildings accessibility standards through a legislative review;
- Enhance inspection capacity to increase compliance;
- Promote awareness of universal design within architecture and construction industries

### **Strategic Direction #4**

- Review financial contribution formulas for disability-related supports;
- Implement individualized programs;
- Develop a legislative framework for supported decision-making

### **Strategic Direction #5**

- Ensure emergency/evacuation planning and responses include accessibility and inclusion practices;
- Provide inclusive services and accessibility training for public service staff

Over the past three years, the Provincial Advisory Council for the Inclusion of Persons with Disabilities has accomplished a great deal, sharing knowledge and experiences related to disability.

The Council initiated discussions with a variety of Provincial Government officials, organizations and individuals with expertise in disability to inform their advice. Some highlights of their advice included:

- Advised NL Housing Corporation on visitability and incorporating Universal Design in social housing
- Advised Service NL on the Buildings Accessibility Act and Regulations
- Advised the Chief Electoral Officer and staff on how to improve accessibility of the provincial voting process
- Advised on the development, implementation and evaluation of the Provincial Strategy for the Inclusion of Persons with Disabilities
- Advised on disability-related issues and solutions regarding supports for living in the community including supports for individuals whose caregivers are aging
- Identified priority areas for advice to the Provincial Government
- Developed a three-year Activity Plan for 2014-2017

Council communicated with the Minister Responsible and advised on a variety of disability-related issues 2013-14, including:

Over the past three years, the Council advised on a variety of time sensitive, emergency, individual or systemic issues regarding barriers to inclusion on an equal basis with others. Some examples of Council advice included: the accessibility of the retrofit of Arts and Culture Centres, program design of Accessible Vehicle and Inclusion Grants, the need for a continued increase in accessible housing throughout

the province, amendments to the *Buildings Accessibility Act* to enable increased accessibility, and broadening program eligibility to be based on need.

# **Opportunities and Challenges Ahead**

The Council is eager to build upon its advice to the Provincial Government on the Provincial Strategy for the Inclusion of Persons with Disabilities, and issues of importance to persons with disabilities.

New members were appointed to the Council in February 2014. Input from the Council will provide an opportunity to continue to build upon its achievements while advancing the Provincial Government's commitment to inclusion.

There are challenges in moving forward in the fiscal year with addressing existing systemic barriers. However, much can be accomplished as priorities are considered:

- Providing guidance on improving Provincial Government policies and services
- Ensuring implementation of initiatives of the Provincial Strategy is cohesive and coordinated and appropriately funded and resourced



# **Appendix A**

# The Provincial Advisory Council for the Inclusion of Persons with Disabilities

#### **Terms of Reference**

#### **Mandate**

The Provincial Advisory Council for the Inclusion of Persons with Disabilities advises and informs the Minister Responsible for the Status of Persons with Disabilities on matters concerning persons with disabilities in Newfoundland and Labrador.

#### **Role and Functions**

The Council:

- Brings knowledge and understanding of disability related issues to government
- Advises government as it develops policies, programs, strategies and recommendations to advance the inclusion of persons with disabilities
- Promotes awareness of disabilities and the barriers faced by persons with disabilities

### **Membership and Structure**

The Advisory Council is comprised of 12 to 18 members appointed by the Minister Responsible for the Status of Persons with Disabilities. From amongst the members, the Minister appoints the chair of the Council to serve a three year term. Council members are appointed for two years.

Council members serve in a volunteer capacity and do not receive remuneration other than reimbursement for expenses to attend meetings. The Council meets up to four times a year. The Disability Policy Office, located within the Department of Advanced Education and Skills, provides secretariat and administrative support to the Council.

#### **Nomination Process**

Individuals with a broad knowledge and understanding of disability related barriers and issues experienced by people with disabilities in this province and interested in serving on the Council shall either complete an Expression of Interest form or be nominated by a third party. Consideration is given to regional, cross-disability and urbanrural representation and gender balance. Nominations are accepted in alternate formats.

The Minister Responsible for the Status of Persons with Disabilities in Newfoundland and Labrador seeks nominations from:

- Members of the House of Assembly
- Community organizations working on disability related issues
- The general public

Advertisements are placed in newspapers province-wide, encouraging nominations to the Council based on the above noted criteria. Further information about the Council and nomination criteria is available from the Disability Policy Office via website, phone or email.

All public documents related to the Council are available in alternate formats upon request.

### Accountability

The Advisory Council reports to the Minister Responsible for the Status of Persons with Disabilities. Under the *Transparency and Accountability Act*, the Council is a Category 3 Public Body and therefore must submit an annual report to be tabled in the House of Assembly. In addition, it must prepare and submit a three year activity report.

# **Appendix B**

# Provincial Advisory Council for the Inclusion of Persons with Disabilities Council Membership

The Provincial Advisory Council for the Inclusion of Persons with Disabilities is composed of 18 community leaders from across the province. The Council has cross disability membership ranging from individuals who have various disabilities, family members and others who have expertise in the area of inclusion. The membership is diverse with men and women who live in rural and urban locations throughout the province.



J. Paul Walsh (Chair) is a Senior Business Analyst with Newfoundland Power Inc., a course instructor at Memorial University and the Academic Dean of Canadian Institute of Management. He holds a Bachelor of Commerce and a Master of Business Administration from Memorial University. He has personal experiences with disabilities. Paul is an executive Board Member of the Coalition of Persons with Disabilities - Newfoundland and Labrador, a member of the Advisory Committee for

Students with Disabilities (Memorial University), and member of the selection committee for the Glenn Roy Blundon Award.



**Norman Austin** works with athletes with disabilities at national and provincial levels. He is a board member of Calypso Foundation, a coach for Special Olympics and a past member of the Municipal Affairs Appeals Board. He is the father of a 34-year old son with an intellectual disability.



**Elizabeth Chaulk** is Associate Vice-President of Learner Services, College of the North Atlantic. She is an exofficio member of the Provincial College of the North Atlantic Advisory Committee for Learners with Disabilities. She is a current director of the Provincial Conservation Corps Board and a member of the Harris Centre Advisory Board, Memorial University.



**Delia Connell** is the Vice-President of Community Services/Aboriginal Affairs and Chief Operating Officer for Central/Northern Labrador with Labrador Grenfell Health. She is an active member and volunteer with local, regional, and provincial groups including Newfoundland and Labrador Association for Community Living, Happy Valley-Goose Bay Special Olympics, Happy Valley-Goose Bay Homelessness/Supportive Living and Happy Valley-Goose Bay Interdisciplinary Committee for Persons with Disabilities. Delia has a daughter who was born with Down Syndrome.



**Don Connolly** is actively promoting awareness and inclusion for individuals with disabilities locally and nationally. He is President of the Canadian Council of the Blind-Newfoundland and Labrador Region. He is also a member of the St. John's Lions Club; and District Chair for Lions Clubs in District 4 which covers 52 Lions Clubs from Gander to St. John's. He is also President of VISRA-NL (Visually Impaired Sport and Recreation Association), and Coordinator of VISUAL (Visually Impaired Students and Seniors Committee Undertaking Active Living).



**Paula Corcoran** is the Provincial Executive Director of Consumers' Health Awareness Network Newfoundland and Labrador (CHANNAL). She has personal and professional experiences in mental health. Paula is involved with the Mental Health Commission of Canada, the Department of Health and Community Services' Recovery Project and Bell's National Mental Health Advisory Committee.
