
This has been another busy and exciting year for the committee. We:

## Mandate

The YAC received authority to operate on May 17, 2001. A press conference on June 13, 2001, announced that the YAC was established because the Provincial Government placed greater focus on youth and was looking for ways to allow youth a stronger voice. Initially, it was created within a new department (Youth Services and Post-Secondary Education) and was part of an effort to coordinate youth services and provide youth with a single contact point. While the responsible department may change, the purpose of the YAC does not. The YAC was created to provide a forum for the “open discussion of key issues affecting the young people of Newfoundland and Labrador” and to advise the departments responsible for youth services and education on the Provincial Government’s youth-related policies and programs.

The YAC, through meetings, consultations, research and public and peer presentations, is fulfilling its mandate and is respected as a voice for the youth of Newfoundland and Labrador.

## Overview

The YAC is comprised of 15 youth members aged 15-29 and 4 adult mentors over the age of 29. All members and mentors are appointed by the Minister of HRLE in consultation with staff responsible for committee operations. The selection criteria include gender, regional location, ethnic representation, educational levels and other areas.

Responsibilities for a Youth Member:

- attend all meetings (where possible);
- prepare for issues to be discussed;
- serve as a member of a sub-committee;
- participate as an equal member;
- must resign if leaving the province for more than six (6) months in a year; and
- may be granted a one-time leave of absence by the Minister for up to six (6) months.

Responsibilities for a Mentor:

- attend all meetings (where possible);
- prepare for issues to be discussed;
- serve as a member of a sub-committee;
- advise and direct the discussions and recommendations of the YAC.

The YAC does not require an audited financial statement. YAC expenditures for 2009-10 were approximately \$70,000. YAC finances are administered by HRLE and each year the YAC budget is determined by the department's budget process. Members and mentors volunteer their time and efforts. Further details can be provided by contacting the Manager of Career, Employment and Youth Services responsible for the YAC at 709-729-6890.

Each year the committee meets with the Minister responsible for youth and presents its annual report outlining its recommendations for that year. The Minister in turn tables the report in the House of Assembly. At this point, the recommendations are circulated to the respective line departments for their action and responses. Responses are sent back to the committee for review and further follow-up.

The YAC has repeatedly given solid recommendations to the Provincial Government. Their dedicated commitment as volunteers has heightened awareness of the Provincial Government's obligation to the province's youth and the policies and programs by which they are governed. The YAC continues to provide a reliable avenue for the voice of youth to be heard.

## Highlights

- ✓ The YAC identified three priority headings for 2009-10:
  - Health
  - Education
  - Employment
- ✓ The YAC consulted with approximately 65 local youth from various regions of the province.
- ✓ The YAC met with the Provincial Youth Retention and Attraction Youth Advisory Panel on two occasions.
- ✓ The YAC consulted with 16 government officials.
- ✓ Two members of the YAC remained members of the Provincial Government's Youth Retention and Attraction Youth Advisory Panel.
- ✓ The YAC received peer presentations from five groups.
- ✓ The YAC met with seven agencies and organizations.
- ✓ The YAC held eight meetings in different communities of the province.
- ✓ Eight members are presently members of the Youth Leadership Team for the Province's Youth Retention and Attraction Strategy's Youth Forum.

## Report of Performance 2009-10

The YAC has continued to contribute to the youth strategic direction of the Department, particularly around the focus areas of youth leadership development, policy development and community participation. Through youth leadership the committee has taken the lead in encouraging youth to be vocal around issues affecting them. The committee has contributed significantly in policy development through the outlined recommendations in its annual report. The committee also consults with line departments on the development of youth policy. In the area of community participation, the committee has held numerous roundtable discussions with both youth and adult stakeholders in its efforts to encourage increased community participation.

The YAC Activity Plan for 2008-11 identified two key objectives which represent the focus of the committee and include performance measurement information (ie: measures and indicators) to assist the committee and the Provincial Government in monitoring and evaluating success.

The following objectives apply to the 2008-09, 2009-10 and 2010-11 fiscal years and will be reported on in the relevant annual reports:

### **Issue 1: Consultations**

The Youth Advisory Committee has endeavoured to improve the consultative process with public stakeholders in an effort to increase the number of individuals and groups consulted and to widen the diversity of those who participate in the consultation process (i.e. geographics, special interests, age, gender). It is felt that by broadening the range of participants in this process, the information gathered will enhance the recommendations put forward by the committee to the Provincial Government related to youth policy and programming.

**Objective:** The YAC will have continued to enhance its consultation process with various public stakeholders.

**Measure:** Enhanced public consultation process.

**Issue 2: Website**

The Youth Advisory Committee realizes that the use of the committee's website is a valuable tool in both distributing and receiving pertinent information relevant to youth issues and policies. With the geographic challenges within our province, the YAC endorses the fact that web-based technology will have to serve as its most acceptable tool for engaging youth from all areas of the province.

**Objective:** The YAC will have modified its website to be more user-friendly and interactive, which will give more access to YAC-related information to the general public.

**Measure:** Website modified.

## Achieving Our Mandate

Throughout this past year, we were able to continue to discuss youth-related issues and to advise the Minister on possible changes in provincial programs and policies. Previous Annual Reports have made many suggestions and, through this Annual Report, we hope to continue seeing positive changes in the provincial programs and policies that affect young people in Newfoundland and Labrador.

In order to address the issues we feel are important, we focus on three main categories of issues per year. In 2008-09, we focused on three categories: *Educational Concerns, Community Matters and Health Issues*. In 2009-10, our three strategic categories are: Health, Education and Employment.

### Health

Above all else, the Youth Advisory Committee realizes that the health of the provinces' youth is its number one concern. The committee has always stressed the importance of physical health and has recently begun identifying the importance of mental health – as seen in the recommendations. Mental health is an area that must be focused on during the early stages of life. Youth who have strong mental health will deal with the difficulties that coincide with becoming an adult with greater success. It is for this reason that investments in our youth today will no doubt bring greater returns in the years to come.

## **Education**

In much of Newfoundland and Labrador – especially rural areas – the school represents the heart of the community. It is the centerpiece of recreation, sports, extra-curricular activities, fundraising and community involvement. The Youth Advisory Committee is dedicated to ensuring the Provincial Government make the most out of their investments in community schools by allowing open access and continual use of existing facilities. Not only does the Committee focus on equal access to schools but also ensuring equal access to programs for students with disabilities. As well, the YAC looks towards the Provincial Government to help promote and advance civic involvement by young people in their communities and in the democratic process. This includes educating youth about the importance of voting and supporting the work the Volunteer and Non-Profit sector performs in our communities.

## **Employment**

Increasing numbers of youth are advancing their education every year by entering into post-secondary institutions. These students are dependent on summer jobs to provide work experience and income to help support themselves for the next school year. The Government of Newfoundland and Labrador is one of the largest student employers in the province. The Committee feels that a review of summer student placements should be conducted to look at job advertising, hiring processes, work descriptions, and duration of employment to name a few. The YAC feels that the Provincial Government can improve on many of these issues which will positively contribute to the public services' image as a preferred employer. As well, the committee would like to stress the importance of the Volunteer and Non-Profit sector in providing services and employment opportunities in the province for youth.

## Recommendations

The Youth Advisory Committee has developed the following series of recommendations based on its deliberations and activities over the past year:

### Health:

- 1) The Youth Advisory Committee recommends a review of mental health services, particularly store front services providing psychiatric assessment. The committee feels psychiatric assessments should be provided in each health authority in the province as opposed to only being offered by Eastern Health. Assessments are a crucial first step for mental health patients and having them uprooted from their family supports to travel to Eastern Health is not effective or helpful in their healing process.
- 2) The Youth Advisory Committee recommends a complete review of all provincial buildings to ensure they have the equipment needed to accommodate those with physical disabilities. The committee was disappointed to discover that not all buildings are equipped with adaptations for the hard of hearing, loss of sight or wheelchair impaired.
- 3) The Youth Advisory Committee recommends that the Provincial Government complete the intended task of legislating smoking in cars with children illegal. As the legislative body, the committee feels the Provincial Government has a responsibility to complete the necessary steps to make this action law.
- 4) The Youth Advisory Committee supports Roots of Empathy in its efforts to educate school aged children on emotions and behaviour as taught through the stages of babies first year. As seen by its rapid growth, the committee recommends that the Provincial include the Roots of Empathy as a school program, giving it the consistency of yearly funding that it requires to run its program throughout the province.
- 5) The Youth Advisory Committee further recommends that Roots of Empathy become a regular chapter during a school child's education of health. The committee feels that this program should be included twice during the child's education, first as an elementary student and again as a high school student.
- 6) The Youth Advisory Committee recommends that the Provincial Government legislate the wearing of helmets while bicycling. Many other provinces in Canada have legislated this act and Newfoundland and Labrador should follow suit to ensure the health and safety of our youth, by legislating that youth 18 years and under wear helmets at all times while bicycling.

**Education:**

- 7) In our annual reports of 2004-05 and 2008-09, the Youth Advisory Committee recommended that the Provincial Government allow public access to schools. The committee continues to discover that many schools are still not accessible to the community. The Department of Education replied that a follow up would attempt to identify any barriers to public access. As well, a discussion regarding the implementation of a Sports and Recreation Strategy with the Department of Tourism, Culture and Recreation would provide resolution of this issue. The committee would like further action taken to see schools become accessible in every way to the public. With many school closures, rural communities are losing their hubs to gather for sports, activities, and community events. The committee feels that this could easily be fixed by making the schools a community asset, whether used for schooling or not.
- 8) The Youth Advisory Committee recognizes the need to relocate students from the School of the Deaf into mainstream schools. We also recognize the need for supports and equipment to make this transition a smooth one. The committee recommends that proper efforts and infrastructure be in place to make this change successful.
- 9) The Youth Advisory Committee applauds the Provincial Government on its Make Your Mark Campaign in 2009; however the committee feels that further efforts need to be taken to encourage youth to vote. The committee recommends that the Provincial Government revisit ways to help youth across the province place their vote. The committee suggests breaking barriers presented by accessibility to voting stations by introducing clearer information on the methods available to vote. As well, more youth participation at polling stations to give youth a face in the political process.
- 10) The Youth Advisory Committee recommends changing the mandate for Elections Newfoundland and Labrador to include efforts to get the people of this province to vote. The Provincial Government mandates should reflect its people, and more than just the process of voting. Its mandate should include encouraging and supporting the people of Newfoundland and Labrador to vote.
- 11) The Youth Advisory Committee recommends that the Provincial Government provide funding to youth organizations, voluntary and non-profit groups to provide information and education on voting and the political process. The Committee feels that a lack of education is the key component of the poor youth turn out during elections, and providing information through their current outlets is a great way to educate our youth to engage in active citizenship.
- 12) The Youth Advisory Committee continues to wait on information from the Provincial Government regarding a proposal on extra curricular bussing as stated

in a reply from one of our previous recommendations. The committee feels that after school bussing remains an important issue and a strong barrier preventing our youth from engaging in extracurricular activities.

- 13) The Youth Advisory Committee recommends that the Provincial Government bring back Global Studies as an available course in Newfoundland and Labrador's education curriculum. The committee supports the Global Education Initiative in its efforts to promote global citizenship, encouraging the interaction and participation of Newfoundland and Labrador's youth.
- 14) The Youth Advisory Committee recommends that the Provincial Government explore other options of grading public exams. The committee has discovered that numerous students have been negatively affected by using the bell curve to grade public exams, thereby affecting their transition into post secondary education and subsequently career choices.
- 15) The Youth Advisory Committee suggests that public exams grade more than their students. The committee feels strongly that these exams have the ability to assess teaching methods and perhaps highlight areas where teaching methods are not working. The Provincial Government should explore these possibilities as a positive venue to change teaching methods and therefore the quality of youth education.
- 16) The Youth Advisory Committee recommends that the Provincial Government explore the return of Books by Mail as a new online ordering library. As many provincial libraries see very little activity, an online library that provides free shipping of books as opposed to the storefront cost of maintaining many libraries, this change could be very cost saving. This new online library could also eliminate the barrier of requiring transportation to nearby communities when libraries are not available.
- 17) While the Youth Advisory Committee agrees that advances in technology can assist those with hearing loss, we would like to emphasize that the hard of hearing and deaf require various supports in addition to technology resources. We are concerned that these supports will be limited and difficult to attain as the needs of persons with hearing loss are individual and vary significantly. Therefore we recommend educational supports be enhanced and delivered on a timely basis to support these students both within the K-12 system and beyond.

### **Employment:**

- 18) The Youth Advisory Committee feels that some student summer placements within the Provincial Government are not essential. A review implemented by the Office of Youth Engagement could be performed to ensure that jobs are both necessary and fulfilling.



- 19) The Youth Advisory Committee recommends that any Provincial Government student summer placements that are not essential be reallocated to non-profit and municipal sectors.
- 20) The Youth Advisory Committee applauds the Provincial Government on the Hiring Apprenticeship Program, but feels there are still barriers for students who require work experience to complete their education. An investigation should commence to determine what barriers exist, and provide the supports needed to make this service valuable to both the employer and student.
- 21) The Youth Advisory Committee recommends that all Provincial Government paid/supported student summer placements include free training for courses that pertain to their employment. Courses such as First Aid, Basic Cardiac Life Saving, Occupational Health & Safety and office management are just some of many courses that should be available to improve a student's workplace experience.
- 22) The Youth Advisory Committee has been informed that there are a lack of summer placements for level I and II students. As some placements include criteria for enrolment in post secondary, the committee recommends changing these criteria to better provide employment to Newfoundland and Labrador's youth.
- 23) The Youth Advisory Committee applauds the Voluntary Non-Profit Secretariat "Who Cares" campaign, and its efforts to sustain employment in their sector. The committee recommends that further efforts, such as providing long term funding and benefits to these organizations could have a positive effect on their employees, as well as consistency in running their programs. These changes could remain coupled by yearly reports to determine their efficacy of long term funding.

The members of the committee look forward to discussing the recommendations in the report as well as tackling new challenges facing youth of this province.

## Appendix A: Terms of Reference

### NEWFOUNDLAND AND LABRADOR YOUTH ADVISORY COMMITTEE

#### **SPONSORING DEPARTMENT:**

Department of Human Resources, Labour and Employment

#### **STRUCTURE:**

- fifteen youth members and four adult mentors
- youth members are between the ages of 15-29 years
- adult mentors are 29 years and above
- no less than two-third youth members and at least one adult mentor will constitute a quorum for a committee meeting

#### **DURATION OF APPOINTMENT:**

The term of youth members will consist of two- or three-year terms. Ten members of the committee will serve for three years and five members will serve for two years.

The term of adult mentors will consist of two mentors serving for three years and two mentors serving for two years.

#### **APPOINTMENT OF MEMBERS:**

All youth members and adult mentors are appointed by the Minister of Human Resources, Labour and Employment in consultation with staff responsible for the operations of the committee.

The selection of replacement members will be cognizant of many issues, including gender, regional location, ethnic representation and other.

#### **REQUIREMENT OF MEMBERS:**

All youth members and adult mentors must make an effort to attend all Youth Advisory Committee meetings and do the necessary preparation for each meeting.

#### **REMOVAL OF MEMBERS:**

If a member misses three consecutive meetings without notifying the Department of Human Resources, Labour and Employment staff representative regarding their inability to attend, the member may be replaced.

#### **RESPONSIBILITY OF YOUTH MEMBERS:**

1. attend all meetings (where possible)
2. prepare for issues to be discussed
3. serve as a member of a sub-committee
4. participate as an equal member
5. a member leaving the province for more than six months per year must resign their position

6. a one-time leave of absence may be granted for up to six months by the Minister of Human Resources, Labour and Employment

**RESPONSIBILITY OF MENTORS:**

1. attend all meetings (where possible)
2. prepare for issues to be discussed
3. serve as a member of a sub-committee
4. advise and direct the discussions and recommendations of the committee as a member

**MEETING RESPONSIBILITIES:**

The Youth Advisory Committee's philosophy is that participation should be a learning experience whereby every member is given an equal opportunity in:

**Chairing of all meetings** will be the responsibility of members, both youth and adults, in the host region for the meeting. The chair structure should be decided during the previous meeting.

**Recording of discussions** is the responsibility of the Department of Human Resources, Labour and Employment staff representative at the meeting.

**Preparation of the agenda** is the responsibility of the member(s) from the next host region with the support from the Department of Human Resources, Labour and Employment staff representative.

**Summary of each meeting** will be compiled and distributed by the Department of Human Resources, Labour and Employment no longer than one month after a meeting.

Information pertaining to the next meeting will be distributed through the Department of Human Resources, Labour and Employment two weeks prior to the next meeting date.

Travel arrangements and accommodations will be coordinated through the Department of Human Resources, Labour and Employment.

**YOUTH ADVISORY COMMITTEE ANNUAL REPORT:**

- The annual report will follow the standard structure for an annual report.
- The completion of the report will be a reflection of the minutes from the Youth Advisory Committee, along with direct recommendations and general discussions.
- The format for the presentation of the annual report and the exact content of the report will be designed by a sub-committee of the committee in conjunction with the Department of Human Resources, Labour and Employment staff.
